An initiation fee of \$5.00 per NEW member must be added to the total dues. (BRANCH BY-LAWS, CHAPTER V, ARTICLE 1 - A.)

DUES ARE PAYABLE JANUARY 1ST AND ARE PAID YEARLY. (BRANCH BY-LAWS, CHAPTER V, ARTICLE 1 - A.)

Hospitalization dues are an additional \$25.00 per year.

A) Family Dues are \$10.00 per year for ALL children in the same household under the age of 18. \*\*Any child (age 18 - 23) who is attending college is now included in the Family Membership as well. If the Family Membership is taken out in a month other than January, February or March (the first quarter of the year) the dues are \$1.00 per month for the remainder of the year.



## DUES are \$32.40 a year which breaks down to \$2.70 per month.

APOSTOLATE DUES (mandatory) are \$2.40 per member per year.

If the Branch does not charge for the Seminary Fund or the additional PR assessment a member pays **\$34.80 per year for membership dues**. If the Branch charges for the PR assessment (an additional \$2.40) and the Seminary Fund (an additional \$1.20) a member pays **\$38.40 per year for membership dues**.

If the Branch charges for the PR assessment but not the Seminary Fund a members pays **\$37.20 per year for the membership dues**. If the Branch does not charge for the PR Assessment but charges for the Seminary Fund a member pays **\$36.00 per year for membership dues**.

If the Branch charges for the PR Assessment the Branch retains **\$8.40 per member per year**. If the Branch does not charge for the PR assessment, the Branch retains from the dues **\$6.00 per member per year**.

If the Branch charges for the seminary fund and the PR Assessment the Branch retains **\$9.60 per member per year**. If the Branch charges for the Seminary fund but not the PR Assessment the Branch retains **\$7.20 per member per year**.
