
To <u>support the clergy</u>, the ICF offers prayers and monetary donations for the continuation of vocations and contributes to the education of young men training for the priesthood.

## BOOK REVIEW Vince Piro

The Song of Francis Tomie dePaola G. P. Putnam's Sons, 2009. 32 pages.

In *The Song of Francis*, Tomie dePaola, award winning author and illustrator, introduces young children to the story of St. Francis de Assisi. These simple words and lively illustrations will delight preschool children and teach them valuable lessons about their relationship with God.

St. Francis is so full of love for God that he wants to sing, but he is alone and there is no one to listen. This discourages Francis until a small angel, who follows Francis everywhere, tells him to sing anyway since God will hear him. So Francis begins to sing. His voice reaches the sky and the sun and moon come to listen to his beautiful song. Then the sky fills with birds - red ones, orange ones, yellow ones, green ones, blue ones and more - who want to listen to Francis' verses. Then, the birds join Francis in his song and "a more glorious sound – a more glorious sight was never seen on earth before." Finally, angels came to listen to this glorious song of love. As evening descends, Francis ends his song and is once again alone, except for the moon and angel. However, now Francis vows, "Tomorrow . . . I shall sing again."

The lessons in this seemingly simple text will appeal to children and adults, too. First, dePaola reminds us that we are never alone, for God is always present in our lives. As the angel reminds Francis when he feels alone and doesn't want to sing, "The loving God will hear you." What's interesting is that God never appears in the book as a character, but his angel appears to inspire Francis and once he begins his song of love to God, Francis' world fills with life. While one cannot see God, he is present everywhere in the life around us.

Children will also experience the power of love. DePaola writes simply yet forcefully: "Love, love, love, went the song." And the page explodes with life and color. Francis appears with his arms outstretched, accept-



ing and loving all things. And the sky fills with both the sun *and* moon. Birds of all colors – orange, blue, green – fly about, chirping as they accompany Francis as he sings. Brightly colored plants and flowers sprout from the ground and delight the eye.

The illustrations in this slim volume are vibrant, pulsating with motion and color that children will find attractive. Each page delights the eye and reinforces the text. For example, when Francis is alone, the reader sees a single Francis on the page with just a couple of plants around him. The pleasant colors are few and more muted, a light purple and burnt orange. Later, when Francis' song of love attracts the sun and moon, the angels and birds, the page bursts with bright colors: yellow, orange, blue, purple, green, and white in various intermixed hues. The page is awash in motion with flying birds and sprouting plants and the pulsating rays of the sun and moon.

This book is filled with the love of God and the life that springs forth from that love. The back cover best summarizes this fine book best: "Celebrate the joy of life."

For older children, DePaola has written *Francis: The Poor Man of Assisi* (Holiday House, February 1990), which retells the story of this adored saint's extraordinary life in a series of vignettes. It was an American Library Association Notable Book. It also includes an introduction, historical notes, and a list of dates that would serve useful for a research paper.

DePaola has been publishing for more than 40 years. He has written and/or illustrated over 200 books. He has written books involving the stories and characters of numerous cultures as well as his Italian heritage, including several books on *Strega Nona*. # Saint Teresa of Avila The Mystical Carmelite

Teresa of Avila was born in 1515, in Avila, Castile, Spain. Her parents were uppermiddle class and raised a family of 10 children. Teresa was described by her biographers as a "bright, imaginative, extraverted and affectionate child." Her closest sibling and constant companion was her brother Rodrigo, with whom she prayed and took particular delight in reading the lives of the saints. As Teresa entered her teens, her mother died. The event caused a very noticeable change in her personality: she began spending much time alone, so much so that it alarmed her father, who placed her in an Augustinian convent where young women were educated.

After a year and a half in the convent, Teresa fell ill so her father took her home to convalesce. There, Teresa seriously considered

the religious life. When she discussed it with her father, he opposed the idea. So, at the age of 20, against her father's wishes, she applied to and was received at the convent of the Incarnation of the Carmelite nuns outside Avila. A year later, no longer opposed by her father, she received the habit and began to give herself wholeheartedly to prayer and penance. Shortly after

her profession, she again became seriously ill and failed to respond to medical treatment-in fact, her doctors gave up on her. As a last resort, her father took her to a famous woman healer, whose "treatment" also failed to cure Teresa's condition (which may have been malignant malaria). Teresa's ailment continued to plague her greatly for three years. Then, for no explicable reason, it diminished and Teresa regained some semblance of health.

Then Teresa experienced a period of time when she began to neglect mental prayer and spend too much time mixing with visitors to the convent. Shortly after her father died, her confessor called her spiritual slippage to her attention so she returned to intensive private prayer. During the next 18 years, Teresa reported that God visited her with intellectual visions and interior communications. These "gifts" brought mixed reviews from those few to whom she described them: some thought she was blessed with God-given mystical experiences; others cautioned her that these were figments of a runaway imagination; some others warned her that these were the work of the devil and that she should break them off promptly. On one occasion, Teresa stated that she was seized with a rapture in which she heard these words spoken to her within her soul: "I will not have you hold conversations with men, but with angels." Even though her reports of the raptures and divine messages caused her great distress, she continued to receive and welcome them for ensuing years.



Teresa was a reformer: both internally and externally. Internally, she resolved to follow the Rule as perfectly as humanly possible. Externally, she acted on a suggestion from her niece that since the nuns at the convent at Avila were too relaxed that a smaller stricter and more private monastery should be established. The proposal met with both strong support and with fierce opposition from religious and laity alike. Finally, in 1562,

an order came from the Vatican that authorized the establishment of the new monastery of St. Joseph. On August 24, 1563, the monastery was dedicated and during the ceremony four novices received the habit of Discalced Carmelites. Now that she had her monastery, Teresa imposed strict enclosure, perpetual silence and austere poverty on her community. Then fol-

life during which she wrote the Way of Perfection and the Meditations on the Canticle. In 1567, the Carmelite general visited Teresa's community and approved of her work. He commanded her to establish other convents along the same line. Within the next few years, Teresa founded seventeen convents, some for men, throughout Spain. Some of the convents were met with opposition, especially the monasteries established for men; however, after some politi-

cal battles within the Carmelite hierarchy,

the issues were resolved in 1580 when Pope

Gregory XIII recognized Teresa's Discalced

Carmelites as a separate province.

lowed the five most peaceful years of her

Teresa was endowed with great natural talents, one of which was writing. She described her experiences with remarkable skill in works that have become spiritual classics. Her autobiography, The Way of Perfection, and The Interior Castle have inspired and guided countless people in their

Teresa was one of the great mystics and apostles of the Church. She was intelligent, practical, charming and deeply spiritual. She was also skillful enough to blend a very active life with a life of deep contemplation.

She died in October, 1582. She was canonized in March, 1622, by Pope Gregory XV and, in 1970, Pope Paul VI declared her a Doctor of the Church-the first woman to be so honored.

Francisco. Richard held many offices in Br. 258 and also served as president of the San Francisco District. At the time of his death. he served as branch deputy to Branch 161 in Larkspur. He rarely missed one of their meetings. Encouraged by other Central Council members, he campaigned and was elected to serve on the Central Council in 1976. He served three years as a Grand Trustee, three years each as Second and First Grand Vice President and served three years as Grand President from 1987 to 1990. A few years later, he was elected to the office of Grand Parliamentarian. He chaired the Task Force, Bylaws/ritual and Organ Donor Committees. He was a past Director of the Transplant Recipients International Organization and member of the San Francisco Italian Athletic Club. He often traveled to branches to encourage organ donations. He was a member of the Military and Hospitaller Order of Saint Lazarus of Jerusalem and bore the rank of Commander. Richard's 37 years as a Federation member and 32 years as a Central Council member, meant a great deal to him. He oftened mentioned that the Federation was an intricate part of his life. He joined because he believed in the fundamentals and purposes of the Federation. Because of his firm belief in the organization and his experience in the business world, he felt he could be a viable member of the governing body. He was that, and much more. Monsignor Daniel Cardelli, Spiritual Director of the Federations remembers, "Richard Valli, a true friend with a friendly roar and a banter with a wink who truly loved the ICF. Like John the Baptist he made the crooked paths straight. I will miss him." A dear and close friend, Past Grand President Larry Marsalli is quoted, "Richard Valli was a man of integrity, was kind and generous and a devoted Federation member. He was a strong believer in proper protocol and doing what was right. I had the privilege of working with him on many committees since we first met in the early seventies. I will miss him as I thought of him as a brother." Our love and sympathy go out to his wife Lillian. May his soul rest in eternal peace.
