Published by Palgrave Macmillan, the series Italian and Italian American Studies has numerous books dedicated to the study of Italian culture and history as well as Italian-American culture and history. In this month's column, I will focus on the books about Italian-Americans. You'll find a diversity of topics and approaches in these books, some meant for the more academic reader, others for the more mainstream reader. #### Frank Sinatra: History, Identity and Italian American Culture

#### Edited by Stanislao Pugliese

No one represents the Italian American journey from undesirable outsiders to embraced citizens better than Frank Sinatra. From impoverished beginnings in an immigrant, single-parent household to world renown as "Chairman of the Board," he beat the odds to become one of the most influential and best-loved artists of the twentieth century. Sinatra's symbolic role to the millions of Italian American immigrants who looked up to him as proof of the American dream was farus and was mean, selfish, and angry? Loving someone like that means:

- 1. We accept an apology and forgive.
- 2. We avoid any kind of revenge.
- 3. We do not gloat at someone's misfortunes.
- 4. We protect that person's reputation by keeping silent.
- . We are polite and courteous at all times.
- We show cooperation, consideration,

communication, collaboration and care.

7. Most of all we pray for that person with all our hearts.

Yes, we can do this and still not like the person, but we will certainly LOVE.

Jesus says, "...Then your reward will be great and you will be children of the Most High, for he himself is kind to the ungrateful and the wicked."

"Be merciful, just as (also) your Father is merciful."



reaching. From teenage crooner to civil rights activist to Reagan Republican, his shifting identity resonated deeply in Italian American culture. Now, a gathering of distinguished historians, journalists and critics explore Sinatra's impact on American culture, from questions of politics and civil rights to Italian mothering, morality, and ethnic stereotyping. These insights place Sinatra at the fulcrum of many controversial and timely issues that lend his influence a new depth and power, not only musically but in a broad historical context.

Stanislao G. Pugliese is Associate Professor of History at Hofstra University and author of *Bitter Spring: A Life of Ignazio Silone* (FSG, forthcoming) and *Carlo Rosselli: Socialist Heretic and Antifascist Exile* (Harvard, 1999).

#### Representing Sacco and Vanzetti Edited by Jerome H. Delamater and Mary Anne Trasciatti

The contributors to this volume, from a range of academic disciplines and artistic traditions, illuminate previously unexplored aspects of the internationally renowned Sacco and Vanzetti case. Rather than take up the question of whether the two Italian immigrant anarchists were guilty, the essays in this book analyze literary-, artistic-, and mass-mediated representations of Sacco and Vanzetti, linking them to stereotypes of so-called "foreigners" and "others" that prevailed in the 1920s, and interrogating those images that prevail in our own age.

Mary Anne Trasciatti is Assistant Professor in the School of Communication at Hofstra University.

Jerome H. Delamater is a professor in the School of Communication at Hofstra University.

#### Carlo Tersca: Portrait of a Rebel By Nunzio Pernicone

This biography reveals the life of one of the American left's most controversial and char-

ismatic figures in the early twentieth century: anarchist, activist, and revolutionary Carlo Tresca. Emigrating to America at age twenty-five from Italy, Tresca became a leader in the fight for workers' rights, alongside activists like Elizabeth Gurley Flynn and Emma Goldman. Tresca played many roles for his cause: newspaper editor, labor agitator and organizer, civil libertarian, anti-fascist, and an indomitable foe of Stalinism. He continued to fight for the rights of the oppressed until gunned down by Mafioso Carmine Galante, a crime which would never be prosecuted. This engaging book not only relates Tresca's adventure-filled story, but brings to life the volatile world of radical politics in early twentieth century America. Nunzio Pernicone is Associate Professor of

History, Drexel University. He is the author of *Italian Anarchism, 1864-1892* and editor of *The Autobiography of Carlo Tresca.* He lives in Newtown, Pennsylvania.

### Oral History, Oral Culture, and Italian Americans

#### By Luisa Del Giudice

Selected Essays from the 38th Annual Conference of the American Italian Historical Association, "Speaking Memory: Oral History, Oral Culture and Italians in America," Los Angeles, November 3-6, 2005. AIHA is devoted to the interdisciplinary scholarly study of the culture, literature, history, sociology, psychology, and politics of Italians in America. This book introduces readers to a wide range of interpretations that take oral history and folklore as the premise with a focus on Italian and Italian American culture in disciplines such as history, ethnography, memoir, art, and music. Del Giudice has assembled a wide range of scholars in this innovative collection.

Luisa Del Giudice is an independent scholar, founder/director of the Italian Oral History Institute in Los Angeles (1994–2007, when the IOHI was dissolved), and professor of Italian folklore at UCLA (1995–2001). She has published widely and has produced many public events in Los Angeles. She is an honorary Fellow of American Folklore Society, and *Cavaliere* of the Italian Republic.

This collection of books represents a major step forward in the study of Italian and, especially, Italian American society and culture. Written by scholars from major universities, they are thorough and challenging explorations of their subjects.


With an early morning start on Saturday, September 4 the delegates were ready to discuss the issues of the Italian Catholic Federation; see the redesigned ICF.org website; find out secrets of two very successful branches; delve into spirituality; and get a chance to ask why by-laws are important.

During the Spiritual Workshop, Rev. Robert Capone, Diocesan Chaplain of the Orange Diocese made a poignant comment that encompassed the theme of the Convention. Fr. Capone said, "Family is a community of life and a school of love."

If the award presentations are the heart of the Convention, the Saturday business session is the nuts and bolts.

After Grand President Rossi made introductions of the Central Council, clergy members, staff, and local committees the Credentials Committee led by Jane Dianda informed the delegates that there were 290 voting delegates, Central Council, Life Members and Life Members Emeritus in attendance.

The election of the Central Council members this year saw 15 candidates for the 12 positions. The candidates' speeches both

reflected each candidate's interest in maintaining their current position on the Central Council, or gave ideas for what they hoped to do in the future.

As has been the case in recent years, the hotly contested topic during the business session was "Branches Requesting to be Excused from the Convention".

According to the handout in everyone's packet there were 2 branches asking to be excused. After a shorter debate than in previous years, both branches were fined.

Grand President Jones presented the Family of the Year Award to The Leonard Family of Branch 36, Monterey, California. With many members of the family present and accounted for, Mr. Edward Leonard spoke on behalf of his family.

"If you are lucky enough to be a member of the Italian Catholic Federation, then you are lucky enough," Mr. Leonard said.

Grand President Jones also presented Jean Bridges of Branch 380, Thousand Oaks, California, with the Young Adult Leadership Award. She too thanked the members of the ICF for this award.

As time was quickly ticking away, it was announced to the delegates that the presentation of proposals and motions would be tabled until the Sunday session due to lack of time.

As the business of the day drew to a close, the festivities of the evening were about to begin.

The delegates and members had a short amount of time to return to their rooms before the Saturday night cocktail party and banquet.

Members descended from their rooms to the banquet hall as the cocktail party was in full gear. The interior corridor was full of friendly faces not only reminiscing on the past, but talking about family, recent trips and vacations.

Once inside the banquet hall members took their seats as the Mistress of Ceremonies, Grand First Vice President Jane Dianda welcomed everyone and introduced the head table.

"What I enjoy seeing is all of you visiting and enjoying all of your company," said Most Rev. M. Joseph Sartoris, Auxiliary Bishop Emeritus of the Archdiocese of Stockton. "God bless you and keep up the good work."

After the dinner, Grand President Jones then presented the Pope John XXIII award to Della Spinelli of Branch 380, Thousand Oaks, California.

Grand President Jones spoke of Mrs. Spinelli's dedication to the Life Centers of Ventura County and her work helping pregnant women with their needs.

"I felt humbled and overwhelmed," Mrs. Spinelli said upon receiving the award. She continued by giving a special thanks to her husband Gino. "Without Gino, I wouldn't be able to be so involved."

"I thank our God for His goodness to allow us to do his work," she said. **S**unday was lined up to be a very busy business session, with the most anticipated topic – the dues increase – still on tap.

Before the Convention proposals could be discussed the delegates were asked to vote for the Central Council members.

The following Central Council Candidates were voted into the Central Council: Leonard Zasoski, Bob Basuino, Roselynne Jarrett, Vince Piro, Jim Friebel, James Acitelli, Andy Pappani, Deborah Rodondi, Marco Galeazzi, Tom Passanisi, Franklyn Lopes, and Teresa Helfand.

Tom Pollicita of Br. 19 and Br. 39 was elected to the Hospitalization Committee, and Las Vegas was selected as the location for the 2015 Convention.

Grand Trustee Leonard Zasoski presented the Central Council's proposal for a \$5.00 yearly dues increase.

After a brief discussion by the delegates, the proposal resoundingly passed without the need for a ballot vote.

Other proposals presented by the Central Council included the following:

Chapter II: Membership – Article 2-E – The delegates passed the proposal to delete "pay initiation fees."

Chapter XI, Elections, Article 2 - B. Note: (2) – The delegates voted to remove the last sentence of Note 2.

Duties of Officers – Chaplain: Chapter XII, Article 1 – The delegates vote to change "the mission of the Universal Church" to "the mission of the Roman Catholic Church".

The Annual Convention: Chapter XVII, Article 3 - G – The delegates voted to change the date from the  $31^{st}$  of May to the  $30^{th}$  of April.

With regards to the proposals submitted by Branch 4, Holy Cross, San Jose, California, the following was decided:

Elections: Chapter XI, Article 2 - H - The delegates voted to suspend an officer who has not paid dues in full by March 31<sup>st</sup> of the new year.

Elections: Chapter XI, Article 2 - I - The delegates voted to change it to, "shall forefeit his or her office," instead of "without a good reason, forfeits his or her office."

Duties of Officers – Financial Secretary" Chapter XII, Article 7-A – The delegates voted to pass the proposed change.

Duties of Officers – Treasurer: Chapter XII, Article 7-A – The delegates voted to accept the proposed change, minus the last line, "... with a copy to be given to each member in attendance."

Duties of Officers – Trustee(s) 1-2: Chapter XII, Article 9 – The delegates voted to accept the proposed change.

Grand President Jones then presented the Mother Teresa Award to Father Louis Vitale, OFM, who jubilantly accepted the award.

Presentations and awards were later given out from the Apostolate/Charity Committee, Membership Committee, Scholarship Committee, Gifts of Love Committee, Heritage Committee, and Ways and Means Committee.

Grand President Jones also made the presentation to Dr. Elliott Vichinsky and Laurice Levine, Thalassemia Outreach Coordinator from Oakland Children's Hospital. Grand President Jones presented a \$58,000 check to Dr. Vichinsky and Laurice Levine. Dr. Vichinsky once again thanked the ICF for its dedication to the patients and program at Oakland's Children's Hospital. Laurice also expressed her gratitude to the ICF and gave an hourly summation of her course of treatment.

After a very busy morning, Grand President Jones concluded the morning business session, where the current and newly elected Central Council members then retired to lunch to vote on the officers of the Central Council.

The Concelebrated Mass was very well attended and The Most Reverend Joseph M. Sartoris, Auxiliary Bishop Emeritus of the Archdiocese of Los Angeles celebrated along with Most Revered Stephen Blaire, Bishop of the Diocese of Stockton; Reverend Monsignor Daniel Cardelli, ICF Spiritual Director; Reverend Monsignor Antonio Cacciapuoti, Los Angeles ICF Archdiocesan chaplain of the clergy performed a beautiful ceremony.

Later in the evening the Sunday Banquet featured Vaughn Suponatime, a Frank Sinatra impersonator. Thanks to the great food, laughter, good music, and lots of dancing, those who attended had a great time. The evening concluded with the Convention Raffle and drawing.

After three fun and inspirational days together, it was time for the annual Convention to come to a close.

At the prayer service conducted by Spiritual Director Msgr. Daniel Cardelli the new Central Council members and officers were installed. The new 2010-2011 face of the Central Council is:

Goodbyes were said and hugs exchanged until everyone can meet again at the 2011 Convention in Foster City, California.

#### Dear Brothers and Sisters,

The Public Relations Committee has been looking for ways to streamline the effort required to format the Bollettino and keep expenses down. First, for efficiency, beginning with the January 2011 issue, only electronic submissions of branch articles and photographs will be accepted for publication.
