Organizing a Membership Drive

Start planning now so that your group will be well organized and prepared as the scheduled date arrives. Here are some easy guidelines to help you along:

1. Ask permission. Your pastor or parish administrator may already have a Ministry or Organization Fair scheduled for the year; gladly welcoming ICF participation. If not, find out which dates would work best with the parish facility schedule. Pick a weekend with the least conflicts.

2. Know the Rules. Your branch should be aware of any parish policies and procedures to be followed. For example, is it okay to set up tables in the vestibule, stuff flyers in the bulletins or make an announcement at the end of each weekend Mass using our two-minute short script? Knowing the rules ahead of time will maintain a healthy working relationship between your branch and the parish staff.

3. Get your members involved. There are plenty of jobs to go around, so delegate! The more people involved, the more excitement you will generate. Appoint a chairperson/committee to carry out the tasks listed below.

4. Develop a flyer/handout. It is a proven fact that a colored flyer will grab much more attention than a simple "blurb" in the church bulletin. If the parish allows, create a handout that simply explains the who's, what's, when's and where's of your branch. Remember to keep it simple yet informative; contact information, meeting times, location, membership eligibility, what is the ICF, etc. This is an effective tool for all of your branch events; put out these flyers at your dinners and parish events too! 5. Coordinate with Parish Staff.

5. Coordinate with Parish Staff. If the parish allows for a bulletin insert, ask the office secretary how many flyers should be printed and when your branch members should be available to stuff the church bulletins. If you need extra help with this, consider asking the parish school or youth group if any of the children could use some extra community service hours. This is a great way to interconnect with other ministries within the parish. Make sure to print several extra copies for your Membership table.

6. Prepare an announcement. If the pastor will allow your branch to make a short announcement, use the two-minute script as a guideline. Appoint someone that is comfortable with talking in front of large crowds and has a clear speaking voice. If the pastor would prefer to do the announcement himself, supply information about the branch's accomplishments and where your team will be located for the membership drive after Mass.

7. Create an ICF Membership Board. Using the Membership Kit that is available on the ICF website, appoint a member to gather branch photos and the necessary supplies to create your ICF Membership Board. Make sure to highlight Bishops' Days, Corporate Communion Masses, Joint Installations, religious events, fundraisers, youth activities, picnics, etc.

8. Set up for success. Coordinate with the parish to set up a table in a welltrafficked area; a place that most everyone will pass by after each Mass. If the area allows, make a banner or large sign that is colorful and easy to read; drawing attention to your table. The table itself should include your Membership Board, ICF brochures, handouts, Bollettinos, posters, memorabilia, balloons; even some hard candies or small giveaway items. Everyone loves to get something for free!

Sign them up. Create an 9 information worksheet for prospective members that include their name, phone number, email address and mailing address. In turn, have something to give them; a business card, brochure or flyer. Invite them to be your guest at the next branch meeting; be sure to let them know the date, time and location. Be sure to check out our "Branch Visitor" and "New Member" packets at www.icf.org for more ideas and resources. So before the "lazy days of summer" begin and everyone goes out of town on vacation, gather your branch members together and organize a Membership Drive. There is no risk and all reward, plus you will have fun in the process!

The Breaking of the Oplatek

I want to share a tradition from my Polish heritage. I can remember my Busia (Grandma) always giving my dad the Oplatek every Christmas and we followed the tradition with him.

One of the most beautiful and most revered Polish customs is the "breaking of the oplatek." The use of the Christmas wafer (oplatek) is practiced not only by native Poles in Poland, but by people all over the world whose ancestors came from Poland.

The "oplatek" is a thin wafer, made of flour and water, put into a metal press with different religious Christmas scenes. Formerly, these were baked by religious and were distributed from house to house in the parish during Advent.

On Christmas Eve, the whole family gathers and waits for the appearance of the first star. With its first gleam, they all approach a table covered with hay and a snow-white table cloth.





The father or eldest member of the family breaks the wafer in half and gives one half to the mother. Then each of them breaks a small part of each other's piece and, after a warm kiss, they wish each other long life, good health, joy and happiness, not only for the holiday season, but for the coming year and for many years to come.

Now the same ceremony is repeated between fathers and their children, as well as among the children, then, with the relatives and even strangers, if they happen to be present. The ceremony over, they all sit down to a tasteful, though meatless supper, after which they sing kolendy (Christmas carols and pastorals) until the time for Midnight Mass, also know as "Pasterka."

<u>Grand Treasurer – Deborah Rodondi</u>

The 2016 budget is looking good.

The Central Council has been keeping expenses down.

<u>Deputy Chairperson – Andy Pappani</u> Andy Pappani emailed the committee regarding the possibility of changing the name "deputy" to something else. The committee will come back in February with a statute change, if we are going to change the name.

The committee is also looking at the term limits of a deputy – how many years can they be at a branch. Right now it's 2 years. Maybe it should change to 4 years for branch deputy and 7 years for the district deputy.

The deputy workshop at the Convention was very good and generated much information. The deputies would like to have a get together on Friday morning instead of Saturday morning at the Convention.

The committee is thinking about having a District Deputy Award that would be presented at the recipient's District Installation.

Apostolate & Charity – Nina Malone

The committee met and set some goals for promoting religious matters. The goals are: educating members on how to properly say the opening and closing prayers, encouraging our clergy to give some spiritual guidance at the meetings. encourage Days or Nights of Recollection or other religious activity. The Committee will be surveying the branches to discover which of these activities are already being done

The Committee is going to encourage branches and make them aware of the Providenza Fund. Donating for non ICF members opens communication about the ICF

The Committee also wants to open feedback with bishop's and clergy about what they want from the Federation. Bob Basuino said that Msgr. Cacciapuoti asked if we could have a room at the Convention for the Blessed Sacrament. The priests can take turn to hear confessions. Roselynne Jarrett said we had the Divine Mercy Rosary at this Convention and no one attended. It would be a great way for the Apostolate Committee to get involved in the Convention. David Botta said that when we used to have confession, no one came, so we did away with it.

By-Laws & Rituals - Leonard Rossi

The proposed Central Council Statute changes were discussed:

Chapter 6-Article 7. Signatories on checks. Proposed change to increase the limit for one signature on a check to up to and including \$1000 and the signatory doesn't sign a check made out to them. Motion from committee. Passed

Add "Grand" to Parliamentarian. Motion Deborah Rodondi/Bob Basuino. Passed.

Page 1, Chapter 1, Intro: Add 5a – Central Council members must remain active members of a branch and pay dues by March 31. Add 5b: Central Council Life Members must remain active members of a branch and pay dues by March 31. Motion Deborah Rodondi/Denise Antonowicz. Passed.

Chapter 1 Intro. Add Article 6: If an issue is not addressed in the Central Council Statues, then it defaults to the branch bylaws until the Central Council statutes are changed. Motion Deborah Rodondi/Rose. Jarrett Passed.

Page 2 Chapter 2. Article 1, delete lines 3 - 8. There will be 20 members on the Central Council - 10 elected and 10 life members. Motion Deborah Rodondi/

Denise. Antonowicz. Roselynne Jarrett said to add about \$1000 to the budget for the additional 2 candidates. This year, we had no one else run for the Central Council. Discussion followed. Motion from committee. Passed.

Page 5 Chapter 3: Add Article 4 and renumber all subsequent articles: A grand officer who has not paid dues by March 31 is suspended from being an officer. Motion Deborah Rodondi/Nina Malone. Roselynne Jarrett said that as we just voted that they would not be a Central Council member if they don't pay by March 31, this would be redundant. Deborah Rodondi rescinded the proposal/ Nina Malone rescinded the second.

Page 13 Chapter 4. Meetings: A Central Council member who fails to attend 2 meetings and is not excused from 2 successive meetings is considered resigned. A Central Council members must, in writing, tell both the office and the Grand President that they wish to be excused from a meeting. Asking to be excused does not automatically make them excused. Motion Deborah Rodondi/Rose Jarrett. Passed.

Page 35, Chapter 8. Article 4: In an event of emergency, a Central Council member must submit in writing to be excused from the Convention. Add 4b: A Central Council member not in good standing will not be seated at the convention. Motion Deborah Rodondi/Franklyn Lopes Jr. Passed.

We are looking at the Articles of Incorporation, as the articles we received from the state of California do not match what we have in the office.

Convention' Director's - Roselynne Jarrett Fresno was a fantastic convention.

Roselynne Jarrett thanked everyone who helped, especially the Fresno District. Roselynne emailed the surveys responses to everyone. All overall responses were good, very good and excellent.

Roselynne Jarrett spoke about the Convention finances. Our contract was for 928 total room nights. To get all our concessions, we needed to have 747 room nights occupied. We only had 670 room nights occupied. Because we were under our total room night commitment, we lost most of our concessions and must pay a penalty to the hotel. Roselynne Jarrett negotiated the penalty down from \$8900 to \$3834. Roselynne has the list of the branches who didn't stay the entire time and she will give the list to the Executive Committee to see if we want to charge those branches a one day fine. Nina Malone said we need some follow through and accountability from the Central Council regarding delegates leaving early. Motion by Bob Basuino/Denise Antonowicz that this year, as good will, send those branches whose delegates left early a letter reminding them that delegates are required to stay for the entire convention and next year they will be fined for leaving early. Motion passed. Roselynne Jarrett does see us making a profit on the convention. Several branches are still outstanding on paying for banquet, souvenir book ads, etc. She will have a full accounting at the February Central Council meeting. We need to work on having the branches pay for Convention items on time. Motion from the committee to increase the delegate registration to \$250 if paid by June 30. After June 30, there is a \$25 per delegate late fee. Motion passed.

Anne Interrante asked about the donations on Sunday and eliminating the public display of giving the donations. It was listed on several of the surveys. She wanted

to know what the committee is doing to follow through on survey suggestions. Roselynne Jarrett said the committee will look at the surveys and take suggestions under consideration.

The Awards Committee now falls under Convention Directors A few administrative changes to the awards are being made and Roselynne will give the changes to the Executive Committee to approve.

Roselynne Jarrett is working getting bids for the 2020 and 2021 conventions. She is looking at seeking two bids - one for a Convention that ends on Monday and one for a Convention that ends on Sunday to see what the pricing difference would be. Grand President Leonard Zasoski sent the branches who didn't attend the convention a delegate packet along with a letter stating we missed them and hope they will attend in 2017

<u>Expansion – Anne Interrante</u>

The committee's goals are to follow up with the newly opened branches, this year. Another goal is to open three more branches by the 2017 convention. Update:

St. Anthony of Padua, Casa Grande: by the end of October, we will know if they are going forward. Right now, there are 20 -25 members and they are having another membership drive at the end of the month. St. William, Chicago: had their information meeting. There needs to be more interest to continue the process. There is a followup meeting this Monday. The pastor really wants the ICF. This would be a reopen of a previously closed branch. Potential new locations:

St. Christopher, San Jose: will be researching in November.

St. Anthony Almaden Valley in Santa Clara. St. Kilian Mission Viejo: this would be a reopen. The Orange District approached Anne Interrante. The Pastor is new but knows the ICF and is enthused.

Gifts of Love – Teresa Helfand

The committee plans to continue the work and further the goals of the program. They are looking at different ways to advertise the program.

Heritage – Denise Antonowicz



1. Charitable donations should not be announced on the microphone. – This suggestion is considered each year as many feel that the donations should be mailed in. the Strategic Plan to cover the costs. <u>Public Relations – Lauren Kilcullen</u> Michelle Feldman and Lauren Kilcullen are committed to keeping the Bollettino on time and in homes the first week of every month. The new ICF website is up.

The Public Relations committee is looking at the advertisement rates for the Bollettino. Do they need to be increased? The last increase was 2011. The committee is also looking at other ways to obtain new 3. Dinners cost too much. – Yes, hotel banquet dining is on the pricey side. This holds true for all catered meals. To help keep the price down, we lock in the banquet pricing when we negotiate a contact a few years in advance.

4. Hospitality rooms: Some missed the evening hospitality rooms, while some liked the extended "Meet the Candidates."

- To comply with the hotel's quiet time rules, the Central Council voted to change the hospitality format. 
Peppe the Lamplighter

<u>UnderCopp'sHill(American</u> <u>Girl History Mysteries)</u>



Joe DiMaggio was the greatest, but he was not the first, and he was not the last. Throughout the hundred years history of USA sports, thousands of Italian Americans went like him after the dream of a better life. Hundreds of them eventually made it, and in dozens even reached the highest points of their sports. Some of them were never to be forgotten. Other fell into oblivion by few years. But if the symbol Joe DiMaggio is enough to represent them all, their stories, often heartbreaking, always compelling, would need an entire book to be told. An ebook like this one.



Hope all of you had a wonderful Thanksgiving with family and friends. Now is the time to take a deep breath and jump into the Christmas Celebrations. At the moment I am in the middle of decorating and baking...two of my favorite things to do at this time of year (of course being with family and friends tops the charts). Anyone who knows me, knows I am not a big fan of sweets (my downfall is appetizers), but I love to bake. I believe it is because one favorite memory for the members in my family was my maternal Nonie's cookies. Her name was Eva and as a young girl/lady she worked at the bakery on Main Street in the town of Pleasanton, California. She had the magic touch when it came to baking. As usual her recipes were a bit vague, and if you watched her bake she would use her hands to measure and know by the feel of the dough that it was ready to bake and the outcome would put a smile on all our faces. In her kitchen there was one cabinet dedicated to cookies and the minute we entered her house we ran to the cabinet to see if it housed our favorite delight (and we each had our special favorite). When she would visit us, she would have Nono carry in a box with 4 one gallon jars of cookies and with excitement we would reach for our favorite

The recipe from my Nonie's kitchen that I want to share this Christmas Season is her Cornflake Cookies. This happened to be my mom June's and brother Bruce's favorite (well the truth is they also had another favorite that I will share sometime in the future).

Cornflake Cookies

4 large eggs

- 2 cups walnuts, chopped
- 2/3 cup flour
- 1 tsp. salt
- 4 cups corn flakes
- 4 tsp. baking powder
- 2 tsp. vanilla
- 2 cups sugar

Beat eggs well, add sugar and vanilla, beat again. Sift flour, salt and baking powder together. Add dry ingredients to egg mixture. Mix well. Gently mix (fold) nuts in. Fold in corn flakes. Drop by small spoonfuls onto a greased sheet (I use parchment instead). They spread out quite a bit when cooking, 3 across and 4 down on cookie sheet is safe (you learn by trial and error).

Bake in 325 degree oven for 12 to 15 minutes or until golden (I cook them in a 310-15 degree oven for 18-20 minutes). I find that cooking at a lower temperature and for a longer period of time guarantees them being crispy.

These are light and fragile. The recipe will fill $1\frac{1}{2}$ one gallon jars.

Through trial and many errors in perfecting the recipe for those of us that are not cookie Diva's like Nonie I can finally say I make them as good as I remember hers. As a child I would love hanging out with her in the kitchen and being her assistant. I was in awe of the fact that she could tap the bottom of the cookie sheet and the cookies would pop loose beautifully. As I got older and started baking on my own, with a sassy tap on those cookie sheets I expected to see the cookies break free in perfection. The joke was on me...one tap and I had ice cream topping not cookies; therefore, today I use parchment!

Nonie's tradition continues, during the holidays my brothers and their families look forward to the variety of cookies I bake and share with all of them. Merry Christmas to you and your family and wishing you a wonderful new Year!

Hoping you might like to share some of your specialties or the family recipes that have been handed down with the members of the ICF. 

"The Odyssey of a Cross"

In 1913 the first cross was erected on Mt Soledad in the La Jolla area of San Diego... It was constructed of wood and called the "Easter Cross." In 1923 it was stolen... After again being erected it was destroyed by fire ... In 1954 a concrete cross was erected. It stands 29 ft high – a 12 ft arm spread – and a base of 43ft.!n 1989 the avalanche of litigation started... Many - including atheists – were relentless in questioning the legitimacy of a religious symbol on public land. Judges have voted against the cross multiple times.

In 1998 the City of San Diego sold the memorial to the Mt Soledad Veterans' Memorial group.. The land was given to the federal government... In 2013 a federal judge ordered that the cross must be removed. In 2014 Congress authorized the Department of Defense sell the cross and land to the Mt Soledad Veterans Memorial people – with conditions... The estimated selling price \$1 million...

The large concrete cross is the key part of the memorial... The base of the cross is surrounded by a myriad of photos and their stories of our service people that have represented the USA in our many wars... This is a place of pride and inspiration. The site is truly unique... Our ICF 'er Tony Anthony (Marine - Lt Col Ret) is a member of the team that long fought for this noble cause... Tony is 1st VP Br 261Long stand this historic memorial to those who have died for our flag and to all the men and women who proudly serve our flag.
