1           **Mission Statement of the Italian Catholic Federation:**

3       “Through families and fellowship, the Italian Catholic Federation promotes  
4       and supports the Catholic faith and its values, encourages apostolic and  
5       charitable works, and celebrates our Italian-American heritage  
6       and all the heritages of our communities.” Rev. 8/30/14

8                               **CHAPTER I - INTRODUCTION**  
9

10           **Article 1** - The Central Council of the Italian Catholic Federation  
11 (hereafter referred to in these Statutes as the Federation) shall be the  
12 governing body of the organization. It is the duty of the Central Council  
13 Members to keep the Catholic spirit intact and to assure the integrity and  
14 continuance of the Federation.

15  
16           **Article 2** - The Central Council is the source of all the powers of the  
17 Federation reserving said powers to them unless otherwise noted in these  
18 Statutes.

19  
20           **Article 3** - The Central Council shall act through committees named  
21 in these Statutes.

22  
23           **Article 4** - The Central Council shall approve the annual budget and  
24 other major expenditures unless otherwise provided herein.

25  
26           **Article 5 - A.** - Elected Central Council Members must maintain full  
27 membership in an active Branch of the Federation in order to maintain status  
28 on the Central Council. If dues are not paid by March 31<sup>st</sup> of the current  
29 year, the Central Council Members will be notified to pay their dues within

1 fifteen (15) days. If not, the Central Council Member will be considered  
2 resigned. (He/She would need to be a Branch delegate to the Convention  
3 and run for an elected Central Council position to return to the Central  
4 Council.) Added 10/15/16 / Rev. 6/9/18

5

6 **Article 5 - B.** - Central Council Life Members must maintain full  
7 membership in an active Branch of the Federation in order to maintain status  
8 on the Central Council and as a Life Member. If dues are not paid by March  
9 31<sup>st</sup> of the current year, the Central Council Life Member will be notified to  
10 pay their dues within 15 days. If not, the Central Council Life Member will  
11 be considered resigned. (He/She would need to be a Branch delegate to the  
12 Convention and run for an elected Central Council position to return to the  
13 Central Council.) Added 10/15/16 / Rev. 6/9/18

14

15 **Article 6** - If not specifically addressed in these Statutes, the Central  
16 Council will be governed by the Branch By-Laws. Rev. 10/15/16

1 **CHAPTER II - ORGANIZATION**

2  
3 **Article 1** - There shall be twenty (20) Members on the Central Council -  
4 ten (10) Elected Members and ten (10) Life Members. All Members of the  
5 Central Council shall be known equally as Central Council Members. The  
6 Spiritual Director serves as an Advisor of the Central Council. Rev. 6/10/06 / Rev.

7 2/14/15 / Rev. 10/15/16

8  
9 **Article 2** - Life Members will be elected at the end of business of the  
10 June meeting of the Central Council, and will be designated as “Life Member -  
11 Elect.” The designated period of service as a Life Member shall begin at the  
12 beginning of the Central Council meeting at the next Annual Convention and  
13 end at the completion of business of the June meeting of the Central Council  
14 following their seventy-fifth (75th) birthday, when an election of a new Life  
15 Member will take place. At that time, the current Life Member shall be  
16 considered Life Member Emeritus - Elect. Rev. 2/11/06 / Rev. 2/14/15/ Rev. Article Number from 2 to 3

17 2/14/15 / Rev. Article Number from 3 to 2 10/15/16

18  
19 **Article 3** - Central Council Members are not eligible to run for the  
20 Central Council if they have reached their seventy-fifth (75th) birthday before  
21 the date of the election. Rev. Article Number from 3 to 4 2/14/15 / Rev. Article Number from 4 to 3 10/15/16

22  
23 **Article 4** - When a vacancy occurs on the Central Council, from among those  
24 serving as Life Members, it shall be the duty of the Central Council to elect a  
25 replacement from current Central Council Members. Notification of an  
26 election for Life Member must be sent to all Central Council Members ten

1 (10) days before balloting. Rev. 10/21/06 / Rev. 2/14/15 / Rev. Article Number from 4 to 5 2/14/15 / Rev. Article  
2 Number from 5 to 4 10/15/16

3

4 **Article 5** - When a vacancy occurs on the Central Council from among  
5 those serving as Elected Members prior to the conclusion of the regularly  
6 scheduled February meeting, the Central Council shall fill that seat by  
7 election. Notification of an election for a Central Council Member for the  
8 remaining part of the one (1) year term must be sent to all Central Council  
9 Members ten (10) days before the balloting. If a vacancy occurs on the  
10 Central Council from among those serving as Elected Members after the  
11 February meeting, that vacancy will be filled in accordance with these Statutes  
12 at the Annual Convention. Rev. 10/21/06 / Rev. 2/14/15 / Rev. Article Number from 5 to 6 2/14/15 / Rev. Article

14

15 **Article 6** - An employee of the Italian Catholic Federation may be a  
16 Central Council Member, however he/she may not hold an office of the  
17 Central Council or serve on the Executive Committee except as an ex-officio  
18 member without a vote. In addition, in an emergency, the Grand President  
19 may appoint any Central Council Member to fill any employee position on a  
20 temporary basis. Added 6/14/08 / Rev. Article Number from 6 to 7 2/14/15 / Rev. Article Number from 7 to 6 10/15/16

## CHAPTER III - OFFICERS

1

2           **Article 1** - The following Officers of the Central Council are elected  
3 and installed at the Annual Convention:

4

5           Grand President	Grand Treasurer
6           Grand First Vice-President	Grand Parliamentarian <small>Rev. 10/15/16</small>
7           Grand Second Vice-President	Grand Trustees (3)
8           Grand Secretary	Grand Sentinel <small>Rev. 10/16/15</small>

9

10           **Note: The Immediate Past Grand President serves as an Ex-Officio**  
11 **Member of the Central Council.\*** Rev. 6/10/06

12

13           **Article 2** - The Central Council shall elect its Officers at the Annual  
14 Convention. Officers shall be elected from among the Central Council  
15 Members. Central Council Members shall not serve as Grand Second Vice-  
16 President, Grand First Vice-President or Grand President without two years  
17 prior membership in the Central Council. Rev. 10/21/06

18

19           **Article 3** - The Officers of the Central Council, except Grand Trustees,  
20 shall be elected by a majority of those present and voting. The Grand Trustees  
21 shall be elected by receiving the highest number of votes of those present and  
22 voting. Announcement of the results of these elections must be made at the  
23 Annual Convention, followed by a formal installation ceremony.



1           **Article 4 - Spiritual Director**

2

3           **A.** - The Spiritual Director, as an advisor, shall promote the religious  
4 spirit, spiritual guidance and counseling throughout the Federation and shall  
5 see that all matters of the Federation are done in accordance with the spiritual  
6 and moral welfare of the organization.   Rev. 6/10/06

7

8           **B.** - The Spiritual Director

9                   1. shall serve as an advisor of the Apostolate/Charity Committee  
10                   (Chapter V, Art. 3 ¶A).

11

12                   2. shall serve as an advisor of the Convention Directors'  
13                   Committee (Chapter V, Art. 5 ¶A).

14

15                   3. shall serve as an advisor of the Executive Committee  
16                   (Chapter V, Article 7 ¶A).

17

18                   4. shall serve as a chairman of the Judiciary Committee  
19                   (Chapter V, Art. 11 ¶A).   Rev. 6/10/06

20

21                   5. shall say Masses for the intentions of donors to the Providenza  
22                   Fund. A stipend shall be paid to the Spiritual Director for saying  
23                   the Masses.   Added 6/12/10

24

25                   6. shall attend Central Council meetings.   Added 6/12/10

1           7. shall assist in the planning of Liturgies for the Annual  
2           Convention, in cooperation with the local Chaplains and Bishop.

3           Added 6/12/10

4  
5           8. shall assist with the appointments of Diocesan Chaplains and  
6           District Chaplains.   Added 6/12/10

7  
8           **Article 5 - Grand President**

9  
10          **A.** - The Grand President shall be the agent of the Central Council and  
11 shall supervise the administrative, financial and general welfare of the  
12 Federation. He/she shall serve as an ex-officio voting member of all  
13 committees.

14          **B.** - The Grand President shall preside at all meetings of the Central  
15 Council, the Executive Committee and the Annual Convention.

16  
17          **C.** - The Grand President may call special meetings of the Central  
18 Council, Executive Committee or any other Central Council Committee.

19  
20          **D.** - The Grand President shall make a report as to the condition of the  
21 Federation, with his/her recommendations, at the meetings of the Central  
22 Council and at the Annual Convention.

23  
24          **E.** - The Grand President only votes in case of a tie vote or when the  
25 vote is being taken by secret ballot.

1           **F.** - The Grand President shall serve no more than two (2) consecutive  
2 one (1) year terms.

3  
4           **G.** - If the office of the Grand President is permanently vacated, the  
5 Grand First Vice-President shall assume that position. Added 6/9/18

6  
7           **Article 6 - Grand First Vice-President**

8  
9           **A.** - In the absence of the Grand President, the Grand First Vice-  
10 President shall assume all of the Grand President's duties and rights.

11  
12           **B.** - The Grand First Vice-President shall serve as an ex-officio voting  
13 member of all committees.

14  
15           **C.** - The Grand First Vice-President shall serve no more than two (2)  
16 consecutive one (1) year terms.

17  
18           **D.** - If the office of the Grand First Vice-President is permanently  
19 vacated, the Grand Second Vice-President shall assume that position. Added 6/9/18

20  
21           **Article 7 - Grand Second Vice-President**

22  
23           **A.** - The Grand Second Vice-President shall in the absence of the Grand  
24 President and Grand First Vice-President assume all their duties and rights.  
25 However, if the chair of the Grand First Vice-President is permanently  
26 vacated, the Grand Second Vice-President shall assume that position. Rev. 6/9/18

1           **B.** - The Grand Second Vice-President shall serve no more than two (2)  
2 consecutive one (1) year terms.

3  
4           **C.** - The Grand Second Vice-President shall serve as an ex-officio  
5 voting member of all committees. Added 6/9/07 / Rev. 6/11/16

6  
7           **Article 8 - Grand Secretary**

8  
9           **A.** - The Grand Secretary shall direct the keeping of the minutes of the  
10 meetings of the Central Council, Executive Committee and the Annual  
11 Convention. The use of an assistant must have the approval of the Executive  
12 Committee.

13  
14           The Grand Secretary shall notify the office staff within three (3) days of  
15 a Central Council meeting or an Executive Committee meeting of any tasks  
16 requiring the action of the office staff. Added 6/12/10

17  
18           **B.** - The Grand Secretary receives correspondence from Districts,  
19 Branches and members of the Federation and assists the Grand President in the  
20 preparation of correspondence.

21  
22           **C.** - The Grand Secretary shall serve no more than four (4) consecutive  
23 one (1) year terms.

1           **Article 9 - Grand Treasurer**

2

3           **A.** - The Grand Treasurer shall supervise, through the Central Council  
4 office, the keeping of all financial records, showing receipts, expenditures and  
5 balances of all Central Council funds.

6

7           **B.** - The Grand Treasurer shall present to the Executive Committee the  
8 monthly financial report. Rev. 10/19/13

9

10           **C.** - The Grand Treasurer shall serve as Chairperson on the Finance  
11 Committee and review the financial records of the Federation before the  
12 Annual Convention. Additionally, it shall be the responsibility of the Grand  
13 Treasurer and Finance Committee to prepare an annual budget for presentation  
14 to and approval by the Central Council at its October meeting. The Grand  
15 Treasurer also serves as an ex-officio voting member of the Hospitalization  
16 Committee. Rev. 6/11/16

17

18           **D.** - The Grand Treasurer shall submit to the Annual Convention the  
19 financial statement of the Central Council for the year ending with the  
20 calendar year preceding the convention.

21

22           **E.** - The Grand Treasurer shall serve no more than four (4) consecutive  
23 one (1) year terms.

1           **Article 10 - Grand Parliamentarian** Rev. 10/15/16

2

3           **A.** - The Grand Parliamentarian shall interpret the meanings of the  
4 Central Council Statutes and Branch By-Laws. Rev. 10/15/16

5

6           **B.** - The Grand Parliamentarian shall see that the Central Council  
7 Statutes and Branch By-Laws are enforced and that all business is conducted  
8 in accordance with said laws. 10/15/16

9

10           **C.** - The Grand Parliamentarian shall present every charge and appeal  
11 before the Judiciary Committee, the Central Council or any other of its special  
12 committees. Rev. 10/15/16

13           **D.** - The Grand Parliamentarian shall serve as Chairperson of the By-  
14 Laws and Rituals Committee. Rev. 10/15/16

15

16           **E.** - The Grand Parliamentarian shall serve no more than four (4)  
17 consecutive one (1) year terms. Rev. 10/15/16

18

19           **F.** - The Grand Parliamentarian shall serve as a member of the  
20 Executive Committee. Added 6/8/19

21

22           **Article 11 - Grand Trustees**

23

24           **A.** - The Grand Trustees shall have access to all the financial records of  
25 the Federation and must report any irregularity to the Executive Committee  
26 immediately.

1           **B.** - They shall review the finances of the Central Council prior to every  
2 meeting of the Central Council and prior to the Annual Convention shall meet  
3 with the Grand Treasurer to review the Financial Report of the Federation.

4  
5           **C.** - The Grand Trustees shall review the annual budget prepared by the  
6 Grand Treasurer before the October meeting of the Central Council.

7  
8           **D.** - The Grand Trustees shall serve no more than two (2) consecutive  
9 one (1) year terms.

10  
11           **Article 12 - Grand Sentinel** Rev. 10/17/15

12  
13           **A.** - The Grand Sentinel shall see to it that no one takes part in a  
14 meeting who has no right to do so. Rev. 10/17/15

15  
16           **B.** - The Grand Sentinel shall serve no more than two (2) consecutive  
17 one (1) year terms. Rev. 10/17/15

## CHAPTER IV - MEETINGS

1

2       **Article 1** - The Central Council shall hold three (3) regular meetings per  
3 year (February, June and October). Additionally, the Central Council shall  
4 hold a meeting at the Annual Convention. All Central Council Members must  
5 be notified of the time and place of all meetings. A simple majority will  
6 constitute a quorum.

7

8       **Article 2** - Special meetings of the Central Council may be called by the  
9 Grand President or by a signed request from at least five (5) Central Council  
10 Members. Rev. 6/9/18

11

12       **Article 3** - A Central Council Member who fails to attend and is not  
13 excused from two (2) successive meetings will be considered resigned.  
14 Exceptions may be considered in cases of emergencies or family special  
15 events. A Central Council Member unable to attend a meeting of the Central  
16 Council shall notify the I.C.F. office and the Grand President in writing, by a  
17 letter and/or e-mail, of his/her reason for requesting an excuse. The Grand  
18 President will inform the Grand Secretary if the member is excused or absent  
19 for recording in the minutes. Rev. 10/15/16

20

21       **Article 4** - No amendment to the Central Council Statutes may be acted  
22 upon at a Central Council meeting unless the author of the amendment has  
23 sent a written copy of the proposed amendment to the Federation Office  
24 (Office) at least fifteen (15) days prior to the meeting. The Office shall mail  
25 such proposed amendments to Central Council Members at least ten (10) days  
26 before the meeting. Rev. 6/9/18



1           **Article 5** - Proposals to change Branch By-Laws made by Central  
2 Council Members shall be presented to the Office at least fifteen (15) days  
3 before the regular meeting of the Central Council. Proposals from Central  
4 Council Members and those of the Executive Committee shall be forwarded to  
5 the Central Council Members at least ten (10) days before the June Central  
6 Council meeting.

## CHAPTER V - COMMITTEES

1

2       **Article 1** - The standing committees of the Central Council are:  
3 Apostolate/Charity, By-Laws and Rituals, Convention Directors, Executive,  
4 Expansion, Finance, Gifts of Love, Heritage, Hospitalization, Judiciary, Live  
5 to Give, Membership, Public Relations, Scholarship, Task Force, Ways and  
6 Means and Workshop. Rev. 9/1/13 / Rev. 10/19/13 / Rev. 6/11/16

7

8       **Article 2 - A.** - The Grand President appoints all committee  
9 chairpersons. Added 6/11/16 \*The Grand President shall have the option to use a  
10 Life Member Emeritus or Member Emeritus as a committee chairperson.  
11 \*Added 6/10/17 The Grand President has the right to appoint other committees as  
12 needed.

13

14       **B.** - The Central Council shall act through committees named in these  
15 Statutes. Except as otherwise noted, the Grand President shall appoint all  
16 committee chairpersons - See Page 2 - Chapter II - Organization - Article 2 -  
17 from within the Elected and Life Members of the Central Council.  
18 Committee members shall be appointed by the Grand President from the  
19 Elected Members, Life Members, Life Members Emeritus and Members  
20 Emeritus. \*Every Elected Member and Life Member of the Central Council  
21 shall be appointed as a full voting member to at least one (1) committee. \*Added  
22 2/9/19 Committee members are entitled to a vote at committee meetings to  
23 which they are appointed. The Grand President may appoint assistant(s), who  
24 provide help to the committee, and advisor(s), who share experience and  
25 knowledge with the committee, from members-at-large or non-members of the

1 Federation, as non-voting members to a Central Council Committee. Rev. 10/21/06 /

2 Rev. 6/9/12 / Rev. 2/14/15 / Rev. 2/9/19

3

4 C. - The Grand President shall have the power to remove and/or  
5 substitute chairpersons and members of committees for cause with the  
6 approval of the Executive Committee. Rev. 6/11/16

7 **Article 3 - Apostolate/Charity Committee**

8

9 A. - The Apostolate/Charity Committee shall be composed of a  
10 chairperson, three (3) members from the Central Council and the Spiritual  
11 Director as an advisor. The Grand President may appoint an additional six (6)  
12 members from the general membership as a screening subcommittee. Rev. 6/10/06

13

14 B. - All matters touching on the Apostolate/Charity Program of the  
15 Federation and all matters of a religious nature shall be the primary concern of  
16 this committee. It shall present its programs and requests for funding through  
17 the Central Council.

18

19 C. - The current National Charity shall remain in force until the  
20 Apostolate/Charity Committee proposes a change. When a change is  
21 proposed, the committee will consult with the Spiritual Director to recommend  
22 three (3) choices to the Grand President. The Grand President will then  
23 present these choices to the Central Council who will select one (1), from that  
24 list, at the next Central Council meeting. Rev. 9/1/13 / Rev. 6/10/06 / Rev. 6/9/18

1           **Article 4 - By-Laws and Rituals Committee** Rev. Article Number from 5 to 4 6/11/15

2

3           **A.** - The By-Laws and Rituals Committee shall be composed of the  
4 Grand Parliamentarian, serving as chairperson, and two (2) members from the  
5 Central Council. 10/15/16

6           **B.** - The committee will review the Statutes of the Central Council, the  
7 Rituals and By-Laws of the Branches. It shall recommend any changes to the  
8 Central Council through the Executive Committee.

9

10           **Article 5 - Convention Directors' Committee** Rev. Article Number from 6 to 5 6/11/16

11

12           **A.** - The Convention Directors' Committee shall be composed of a  
13 chairperson, five (5) members from the Central Council, one (1) member from  
14 the membership-at-large and the Spiritual Director as an advisor. Rev. 6/10/06

15

16           **B.** - The committee shall prepare and recommend the Convention  
17 program to the Executive Committee and Central Council and supervise all  
18 phases of that program, reporting directly to the Executive Committee.

19

20           **C.** - The committee shall investigate possible sites for future Federation  
21 Conventions and make its recommendation to the Executive Committee for  
22 approval. No more than two (2) committee members, not including the  
23 chairperson or ex-officio members, shall visit a prospective site if expenses are  
24 incurred. Rev. 6/8/19

1 **D.** - The Convention Directors' Committee will promote the Convention  
2 Awards program. The committee will screen the applications for the Pope  
3 Saint John XXIII Award, Grand President's Award, Saint Teresa of Calcutta  
4 Award, Young Adult Leadership Award and the Family of the Year Award.  
5 The committee will select the three (3) finalists in each category. Summaries  
6 of the three (3) applicants selected are to be e-mailed or mailed to each voting  
7 Central Council Member ten (10) days before the June Central Council  
8 meeting. Actual material submitted in support of candidates for these awards  
9 must be available for review at the June meeting. The Central Council  
10 Members will review the applications/summaries and vote at the June Central  
11 Council meeting. Selection in each category will be by a simple majority of  
12 those voting. Added 6/11/16

13

14 **Article 6 - Gifts of Love Committee** Rev. Article Number from 7 to 6 6/11/16

15

16 **A.** - The Gifts of Love Committee shall be composed of a chairperson  
17 and two (2) members from the Central Council. Two (2) additional members,  
18 either from the membership-at-large or non-members who are knowledgeable  
19 in the programs and needs of developmentally disabled persons, may be  
20 appointed to this committee. The Grand President may, at the request of the  
21 chairperson of the committee, appoint additional members on an as needed  
22 basis.

23

24 **B.** - The committee will be responsible for all aspects of this program  
25 including fund raising and the selection of recipients for financial assistance.  
26 The committee shall report directly to the Central Council

1           **Article 7 - Executive Committee** Rev. Article Number from 8 to 7 6/11/16

2

3           **A.** - The Executive Committee shall consist of the Grand President,  
4 Grand First Vice-President, Grand Second Vice-President, Grand Secretary,  
5 Grand Treasurer and Grand Parliamentarian.\* (Grand Parliamentarian Added 6/8/19) The  
6 Immediate Past Grand President serves as an ex-officio voting member. \*The  
7 Spiritual Director serves as an advisor. Officers of the Central Council will  
8 hold that same office on the Executive Committee. Additionally, three (3)  
9 members of the Executive Committee will be elected from among the Central  
10 Council Members at the meeting held at the Annual Convention. Rev. 6/10/06 / Rev.

11 6/11/16

12

13           **B.** - If a seat of an elected Executive Committee member should become  
14 vacant, the Central Council will fill that seat by election at its next meeting.  
15 Notice of such election shall be sent to all Central Council Members at least  
16 ten (10) days before the meeting.

17

18           **C.** - The Executive Committee shall meet at least nine (9) times per  
19 year. The Grand President may call special meetings. Notification of the  
20 time and place of all Executive Committee meetings shall be sent to all  
21 committee members. A simple majority will constitute a quorum at regular  
22 and special meetings of the Executive Committee. Rev. 6/9/07

23

24           **D.** - The Executive Committee shall review the application for the  
25 establishment of new Branches.

1           **E.** - The Executive Committee must pre-authorize the purchase/payment  
2 of all items not considered to be part of the routine day-to-day operation of the  
3 Federation, authorize those individuals entitled to sign checks drawn on  
4 Federation accounts and determine the salary of all Federation employees.

5  
6           **F.** - The Executive Committee will act as a conciliatory body when  
7 disputes arise within the Federation and advise the Grand President on  
8 appointments to Committees of Investigation when such committees become  
9 necessary. If the Executive Committee is unable to reach a peaceful  
10 settlement of any dispute, they shall refer the matter to the Judiciary  
11 Committee.

12  
13           **G.** - The Executive Committee shall review and approve changes  
14 recommended by the Finance Committee regarding the investment of Central  
15 Council funds.

16  
17           **H.** - The Executive Committee shall be kept informed when problems

25           **J.** - The duties of the Executive Committee as listed herein shall in no  
26 way deprive or limit the Central Council of its right to direct the Federation.

27 Deleted Article H (Moved to Article 8 - D.) - Re-Labeled K to J Rev. 6/9/18

1           **Article 8 - Expansion Committee** Added 9/1/13 / Rev. Article Number from 9 to 8 6/11/16

2

3           **A.** - The committee shall be composed of a chairperson and two (2)  
4 members from the Central Council. Additional members from either the  
5 Central Council or the membership-at-large can be asked to assist with  
6 carrying out expansion efforts. Added 9/1/13

7

8           **B.** - The committee shall be responsible for opening, reopening,  
9 relocating and reorganizing Branches. Added 9/1/13

10

11           **C.** - An appointed member of the Central Council shall meet quarterly,  
12 if possible, with new and reopened Branches for the first year the Branch is  
13 open. Added 9/1/13 / Rev. 6/9/18

14

15           **D.** - The Expansion Committee shall oversee the opening of each new  
16 Branch so that it will be celebrated in a fitting manner and according to the  
17 approved rituals of the Federation. Additionally, they will ensure that  
18 guidance and instruction is provided to the officers of the new Branch. Added 6/9/18

19

20           **Article 9 - Finance Committee** Rev. Article Number from 10 to 9 6/11/16

21

22           **A.** - The Finance Committee shall be composed of the Grand Treasurer,  
23 serving as Chairperson, the Grand Trustees, the Grand Second Vice-President  
24 (ex-officio and voting) and up to three (3) Central Council Members. Rev. 6/9/07 /

1 The Chairperson of the Hospitalization Committee shall serve as an ex-officio  
2 voting member of the Finance Committee. Added 6/13/09 / Rev. 6/11/16

3 **B.** - The Finance Committee shall analyze the investment of the funds  
4 of the Federation and is empowered to make reasonable and prudent changes,  
5 with the approval of the Executive Committee, to the investment of the funds  
6 of the Federation. All changes must concur with the Investment Policy  
7 Statement approved by the Central Council. All changes shall be reported to  
8 the Central Council at their next meeting after the change is made. The  
9 committee shall meet a minimum of twice (2) a year and shall review the  
10 annual budget before it is presented to the Central Council for approval.

11 **C.** - The committee shall determine the amount of the Providenza  
12 Seminary Scholarship Fund to be allocated to each Diocese based on a  
13 proportionate share according to the number of Federation members in each of  
14 the Dioceses. The amount shall be evaluated by the committee annually and  
15 presented to the Central Council for their approval.

16  
17 **D.** - With the approval of the Executive Committee and the Central  
18 Council, the Finance Committee shall develop policies for reimbursement for  
19 Central Council Members on official business.

20  
21 **E.** - The Finance Committee shall recommend to the Executive  
22 Committee who in turn shall recommend to the Central Council (at the June  
23 meeting) the per diem and travel allowances for Central Council Members  
24 attending the Annual Convention.

1           **F.** - The Finance Committee shall prepare an annual budget for  
2 presentation to and approval by the Central Council at its October meeting.

3  
4           **G.** - The Finance Committee shall submit to the Executive Committee  
5 the amount of funds available for salary and benefits for all Federation  
6 employees by October 10<sup>th</sup> of each year. The Executive Committee then shall  
7 make recommendations on compensation packages for individual employees.  
8 The recommendations of the Executive Committee shall be presented to and  
9 voted upon by the entire Central Council at its October meeting. (Note: This  
10 provision will require a meeting of the Executive Committee in October.) The  
11 presentation and discussion of compensation packages for individual  
12 employees shall be done in Closed Session at the Central Council meeting.

15           **Article 10 - Heritage Committee** *Rev. Article Number from 11 to 10 6/11/16*

17           **A.** - The Heritage Committee shall be composed of a chairperson and

20  
21           **B.** - The committee will supervise all heritage activities and it shall  
22 present its programs and requests for funding through the Central Council.

23  
24           **Article 11 - Hospitalization Committee** *Rev. Article Number from 12 to 11 6/11/16*

25  
26           **A.** - The Hospitalization Committee shall be composed of two (2)  
27 members nominated from and elected by the Central Council Members and

1 two (2) members nominated from and elected by the delegates at the Annual  
2 Convention. The Grand President shall appoint one of the elected Central  
3 Council Members of the Hospitalization Committee as its chairperson. The  
4 terms of the two (2) members elected by the Central Council and the two (2)  
5 members elected by the delegates shall be respectively two (2) and one (1)  
6 years. A member elected for a term of two (2) years shall thereafter replace  
7 the annual outgoing member. The Central Council shall fill vacancies  
8 occurring during a member's term so that there will be two (2) Central  
9 Council members and two (2) members from the membership-at-large.

11 **B.** - All matters concerning payment to subscribers from the  
12 Hospitalization Program shall be within the province of this committee. Any

16 **C.** - The Hospitalization Committee shall make recommendations to the  
17 Executive Committee and the Central Council pertaining to prudent changes in  
18 the plan.

19

20 **D.** - The Chairperson shall report the financial condition of the  
21 Hospitalization Fund to the Central Council at its meetings and to the  
22 delegates at the Annual Convention. A fee of fifteen percent (15%) shall be  
23 charged by the Central Council to administer the fund.

24

25 **E.** - The Chairperson of the Hospitalization Committee shall serve as an  
26 ex-officio voting member of the Finance Committee. Added 6/13/09 / Rev. 6/11/16

1           **F.** - The Hospitalization Committee shall meet prior to the October  
2 Finance Committee meeting. The purpose of this meeting will be to determine  
3 the allocation and propose the dollar amount of Hospitalization monies to be  
4 transferred for the upcoming year. The Committee's recommendation shall be  
5 presented at the October Finance Committee meeting, in order for the  
6 recommended amount to be included in the proposed budget. The  
7 Chairperson of the Hospitalization Committee shall present the proposal to the  
8 Central Council at its October meeting. Added 6/8/13

10           **Article 12 - Judiciary Committee** Rev. Article Number from 13 to 12 6/11/16

11  
12           **A.** - The Judiciary Committee, composed of five (5) members, shall  
13 only be formed when the existence of an appeal or any other judicial matter is  
14 pending. The Spiritual Director of the Central Council shall serve as  
15 Chairperson. The Grand President shall appoint four (4) committee members,  
16 composed of two (2) members from the Central Council and two (2) members  
17 from the membership-at-large, in matters pertaining to Districts, Branches  
18 and/or individual members. The Central Council shall elect four (4) members  
19 from the Central Council in matters pertaining to a Central Council Member, a  
20 Member Emeritus or a Life Member Emeritus. The committee will be  
21 dissolved upon settlement of the appeal or judicial matter for which it was  
22 formed.

23  
24           **B.** - All matters referred to the Judiciary Committee must be submitted  
25 in writing, clearly stating the details of the matter in question. Upon receipt of  
26 the written statement the committee has the power to inspect books, call

1 witnesses and make local visits when necessary to gather information essential  
2 to making a fair judgement on the matter.

3

4 **C.** - Appeals on decisions of the Judiciary Committee may only be  
5 made to the entire Central Council. Notice of such appeal must be sent in  
6 writing to each Central Council member ten (10) days in advance of the  
7 meeting. Seventy-five percent (75%) of the members voting are necessary to  
8 overturn a decision of the Judiciary Committee.

9 **Article 13 - Live to Give Committee** Added 9/1/13 / Revised Article Number from 14 to 13

12 **A.** - The committee shall be composed of a chairperson and two (2)  
13 members from the Central Council. A consultant with blood or organ donor  
14 background may be appointed. Added 9/1/13

16 **B.** - The committee shall be responsible for promoting the blood and  
17 organ donor awareness programs. Added 9/1/13

18

19 **Article 14 - Membership Committee** Rev. Article Number from 15 to 14 6/11/16

20

21 **A.** - The Membership Committee shall be composed of a chairperson  
22 and four (4) members from the Central Council.

23

24 **B.** - The committee shall prepare, propose and promote an annual  
25 membership campaign to the Central Council.

26 Rev. 9/1/13

1           **Article 15 - Public Relations Committee** Rev. Article Number from 16 to 15 6/11/16

2

3           **A.** - The Public Relations Committee shall consist of a chairperson, two  
4 (2) members from the Central Council and one (1) member selected from the  
5 membership-at-large. Serving as an ex-officio non-voting member is the  
6 Editor of the Bollettino. Rev. 6/11/16

7

8           **B.** - The committee shall review matters concerning public relations,  
9 publicity, income and expenditures of the Bollettino and make  
10 recommendations to the Executive Committee and/or the Central Council.

11

12           **C.** - The committee shall review the policies to be maintained by the  
13 official publication, the Bollettino. The committee shall assist in the selection  
14 of the editor for recommendation to the Executive Committee.

15

16           **D.** - The committee shall be responsible for maintaining and updating  
17 the Federation's official Web site. It may work with a webmaster to fulfill  
18 these responsibilities. The committee shall assist in the selection of the  
19 webmaster for recommendation to the Executive Committee. Rev 10/19/13

20

21           **Article 16 - Scholarship Committee** Rev. Article Number from 17 to 16 6/11/16

22

23           **A.** - The Scholarship Committee shall be composed of a chairperson,  
24 three (3) members from the Central Council and one (1) member who may be  
25 selected from the membership-at-large. The Grand President may also appoint  
26 six (6) additional members from either the Central Council Members or the

1 membership-at-large to assist with the screening and judging of the first year  
2 awards. Rev. 2/12/05

3

4 **B.** - The committee shall promote and conduct the scholarship program  
5 of the Federation and shall seek funding from and report directly to the Central  
6 Council. Additionally, the committee will seek further funding from the  
7 Districts, Branches and individuals.

8

9 **Article 17 - Task Force Committee** Rev. Article Number from 18 to 17 6/11/16

10

11 **A.** - The Task Force Committee shall be composed of a chairperson,  
12 five (5) members from the Central Council and one (1) member from the  
13 membership-at-large.

14

15 **B.** - The committee will study and evaluate topics referred to it by the  
16 Grand President and report to the Executive Committee and Central Council.

17

18 **C.** - The chairperson is empowered to invite qualified members-at-large  
19 and non-members to attend meetings for the purpose of gaining their insight  
20 on subjects being considered.

21

22 **Article 18 - Ways and Means Committee** Rev. Article Number from 19 to 18 6/11/16

23

24 **A.** - The Ways and Means Committee shall be composed of a  
25 chairperson and two (2) members from the Central Council. Additional  
26 members can be asked to assist.

1           **B.** - The committee shall be responsible for fund raising activities of the  
2 Central Council.

3  
4           **C.** - The committee shall be responsible for establishing group travel  
5 trips and program.

6  
7           **Article 19 - Workshop Committee** Rev. Article Number from 20 to 19 6/11/16

8  
9           **A.** - The committee shall be composed of a chairperson and three (3)  
10 members from the Central Council. Additional members from either the  
11 Central Council or the membership-at-large can be asked to assist with  
12 carrying out workshops.

13  
14           **B.** - The Workshop Committee shall be responsible for planning and  
15 carrying out Workshops in the various areas where the Federation is  
16 established. Subject matter may vary according to the needs of the area being  
17 visited, and may include but not be limited to duties of Branch officers and the  
18 history, policies and programs of the Federation.



1                   **CHAPTER VI - FUNDS OF THE CENTRAL COUNCIL**

2

3                   **Article 1 - Apostolate Fund**

4

5                   **A.** - The Apostolate Fund shall be used by the Central Council for the  
6 expenses of the Spiritual Director and for payment of expenses directly or  
7 indirectly related to the religious purposes of the Federation. Two dollars and  
8 40 cents (\$2.40) of the yearly Membership Dues is assessed for the yearly  
9 Apostolate Dues. Rev. 6/8/13

10

11                   **B.** - The Central Council shall allocate 80 cents (\$.80) of the yearly  
12 Apostolate Dues to maintain the fund. Added 6/8/13

13

14                   **Article 2 - Charity/Relief Fund** Rev. 2/9/08

15

16                   **A.** - The Charity/Relief Fund of the Federation shall be at the disposal  
17 of the Central Council to be used only in special cases for charity or in case of  
18 a public calamity. Each case shall be examined and decided by the Central  
19 Council, or by the Executive Committee, when time is of the essence. Rev. 2/9/08

20

21                   **B.** - The Central Council shall allocate 10 cents (\$.10) of the yearly  
22 Apostolate Dues to maintain the fund. Rev. 6/8/13

23

24                   **Article 3 - Providenza Seminary Scholarship Fund**

25

26                   **A.** - The Providenza Seminary Scholarship Fund shall be maintained by  
27 the Federation for the purpose of making annual donations to the Ordinaries of

1 the Dioceses in which the Federation is located. This donation is to be  
2 earmarked for the benefit of individual seminarians in each Diocese.

3

4 **B.** - The Central Council shall allocate one dollar and 50 cents (\$1.50)  
5 of the yearly Apostolate Dues to maintain the fund. Additionally, voluntary  
6 donations to the fund will be accepted. Rev. 6/8/13 / Rev. 10/17/15

7

8 **Article 4 - General Fund**

9

10 The General Fund shall be used by the Central Council for all general  
11 revenue and expenses of the Federation including per capita tax, running the  
12 office, payroll, expenses of the Central Council, Annual Convention,  
13 Bollettino, insurance, and other miscellaneous revenue and expenses not  
14 covered by the other funds listed herein.

15

16 **Article 5 - Hospitalization Fund**

17

18 The Hospitalization Fund shall be used to account for dues collected  
19 from the subscribers of the Plan, and payments made to the subscribers, in  
20 accordance with the Statutes pertaining to the Hospitalization Committee.

21 A fee of fifteen percent (15%) shall be charged by the Central Council to  
22 administer the fund.

1           **Article 6 - Futures Fund**

2  
3           The Futures Fund shall be used by the Central Council to account for funds  
4 received for specific purposes, and payments made to the specific purposes for  
5 which the funds are collected, such as Scholarship, Gifts of Love, the National  
6 Charity, and other miscellaneous donations not covered under other funds  
7 described herein.

8  
9           **Article 7 - Signatories** Added 10/19/13

10  
11           **A.** - The Grand President and Grand Treasurer shall be signatories on the  
12 accounts of all Central Council funds. A total of four (4) additional signatories  
13 shall be selected from among the Central Council Life Members, Elected  
14 Members, Life Members Emeritus or Members Emeritus at the September  
15 Executive Meeting.

16  
17           **B.** - Two signatures are required for each check disbursed from the Central  
18 Council funds that exceed one thousand (\$1,000.00) dollars. Signatories shall not  
19 sign checks made out to them. Rev. 10/18/14 / Rev. 10/15/16

20  
21           **C.** - Signatories must ensure that proper documentation, such as a receipt,  
22 contract or invoice verifying the total to be reimbursed, is provided. Added 10/18/14



1           **B.** - When a Branch has (a) fewer than twelve (12) members, (b) been  
2 delinquent for six (6) months in payment of per capita or assessments to the  
3 Central Council, (c) shown disrespect toward the authority of the Central Council,  
4 (d) shown the absence of Catholic spirit in the conduct of its members or (e)  
5 failed to hold regular meetings or acts of officers indicating practical dissolution,  
6 a representative of the Executive Committee shall investigate. When necessary,  
7 he/she shall take control of all ledgers and properties of the Branch, declare all  
8 offices vacant and proceed to endeavor to reorganize the Branch. He/she shall  
9 report progress or lack thereof at the earliest meeting of the Executive Committee  
10 who shall then decide on further necessary steps.

11

12           **C.** - The Central Council has the right, by a majority vote at any of its  
13 meetings, to suspend or dissolve any Branch.

14

15           **D.** - Members in good standing shall be encouraged to transfer to other  
16 established Branches.

## CHAPTER VIII - THE ANNUAL CONVENTION

1

2       **Article 1** - The Annual Convention shall be held each year on the Labor  
3 Day Weekend. The Central Council reserves the right to change the selected site  
4 if special circumstances should occur such as fire, flood, acts of God, labor  
5 disputes or the selected hotel's inability to perform in accordance with the signed  
6 contract. Rev. 6/8/19

7

8       **Article 2** - The Grand President shall preside at all meetings of the Annual  
9 Convention.

10

11       **Article 3** - The Finance Committee shall recommend to the Executive  
12 Committee who in turn shall recommend to the Central Council (at the June  
13 meeting) the per diem and travel allowances for Central Council Members  
14 attending the Annual Convention. Per Diem shall only be paid for Convention  
15 days when the Central Council Member actually attends Convention activities,  
16 and shall not be paid for days when the Central Council Member leaves early.

17

18       **Article 4 - A.** - Central Council Members shall attend the Annual  
19 Convention as a delegate-at-large with the right to vote, to be re-nominated for a  
20 position on the Central Council and to nominate prospective members for the  
21 Central Council. In the event of an emergency that causes an elected Central  
22 Council Member to ask to be excused, said Central Council Member will submit  
23 a letter and/or e-mail stating his/her desire to run for the Central Council. This  
24 Central Council Member can also be nominated for a Central Council Office in  
25 absentia by submitting a letter and/or e-mail. The Grand President, with the

1 assistance of the Grand Parliamentarian, will make the final decision. Rev. 10/17/15 /

3  
4 **Article 4 - B.** - A Central Council Member who has not paid dues by  
5 March 31<sup>st</sup> of the current year will not be considered in good standing and shall  
6 not be seated at the Annual Convention as a Member-at-Large of the current year.  
7 The Central Council Member not in good standing will have no voting privileges  
8 at said Convention. Added 10/15/16

9  
10 **Article 5 - A.** - The order of discussions of proposals at the Annual  
11 Convention shall be prepared in advance by the Grand Parliamentarian and  
12 approved by the Central Council. Matters presented by the Central Council shall  
13 have precedence. All other proposals to be presented at the Annual Convention  
14 must be accepted by the Central Council before presentation.

15 Rev. 10/15/16

16  
17 **B.** - The Central Council is authorized to eliminate proposals: (1) clearly  
18 unconstitutional, discriminatory (except as to the age for benefits) or infringing  
19 on the fundamental principles of the Federation, (2) defeated at the immediate  
20 previous Annual Convention, except if the Central Council approves them for re-  
21 presentation.

**CHAPTER IX - MENTOR PROGRAM** Rev. 6/10/17

1

2       **Article 1** - The Grand President shall appoint the Chairperson of the  
3 Branch Mentor Program from among the Central Council Members. The Branch  
4 Mentor Program Chairperson shall appoint all District Mentors with the  
5 recommendation of the District President and District Council and appoint all  
6 Branch Mentors in consultation with the District Mentor. Rev. 6/10/17

7

8       **Article 2** - The representatives of the Central Council in each Branch shall  
9 be known as the Branch Mentors. The District Mentors shall coordinate the  
10 activities of the Branch Mentors in his/her District. The District Mentors shall  
11 report directly to the Chairperson of the Branch Mentor Program.

13

14       **Article 3** - Branch Mentors \*shall submit a report after each Branch  
15 meeting the attend on the activities and condition of the Branch to the District  
16 Mentor who, in turn, will submit quarterly reports to the Chairperson of the  
17 Mentor Program. Urgent matters shall be reported immediately. Rev. 6/10/17 / \*Rev. 6/13/20

18

19       **Article 4** - The Chairperson of the Branch Mentor Program will meet with  
20 the District Mentors on a quarterly basis by mail, phone or at the annual  
21 Convention. Rev. 6/10/17

23       **Article 5** - The District Mentor shall be an ex-officio voting member of  
24 his/her District Council, shall be given recognition with a distinctive insignia and  
25 be given honors due Central Council Members. Rev. 6/10/17



1           **Article 6** - District Mentors shall remain in office for a maximum of a  
2 seven (7) year term and Branch Mentors for a four (4) year term with an assigned  
3 Branch or until his/her successor has been appointed. All District Mentors and  
4 Branch Mentors are subject to removal at any time by the Chairperson of the  
5 Branch Mentor Program or the Grand President. Rev. 6/10/17

6  
7           **Article 7** - Branch Mentors shall (1) attend a meeting of the Branch they  
8 are assigned at least once a quarter or as needed (Rev. 6/13/20), (2) do all in their  
9 power, with a positive attitude, to see that the Branch under their mentorship  
10 maintains the Catholic spirit of the Italian Catholic Federation and its By-laws (Rev.  
11 6/13/20), (3) assist the Branch President as needed on procedures, items to discuss  
12 and future events (New Statement Added 6/13/20), (4) shall not make motions or engage in the  
13 discussion of motions or Branch business unless requested by the Branch (New  
14 Statement Added 6/13/20), (5) settle difficulties within their assigned Branch (Rev. Number from 3 to 5  
15 6/13/20), (6) be responsible for instructing and training Branch officers of their duties  
16 and explaining the charities and benefits that the Italian Catholic Federation has  
17 to offer (Rev. Number from 4 to 6 6/13/20), (7) install new Branch officers, as needed, and  
18 initiate new members but may yield this responsibility to the District Mentor or a  
19 Central Council Member (Rev. Number from 5 to 7 6/13/20), (8) shall execute the directives of  
20 the Central Council or Executive Committee whether conveyed directly or  
21 through the Chairperson of the Branch Mentor Program (Rev. Number from 6 to 8 6/13/20), (9)  
22 shall have the right to a distinctive insignia and receive the honor due to a Central  
23 Council Member (Rev. Number from 7 to 9 6/13/20), (10) shall be a voting member of the  
24 District Council (Rev. Number from 8 to 10 6/13/20). Rev. 6/10/17

25  
26           **Article 8** - District and Branch Mentors are required to participate in any  
27 Mentor Program training. Rev. 6/10/17 / Rev. 6/13/20

1           **Article 9 - A.** - The interpretation, decisions and settlements of the Branch  
2 Mentor are binding to the Branch, subject to appeal. Rev. Article Number from 8 - A. to 9 - A.

3 6/13/20

4  
5           **Article 9 - B.** - Appeals by the Branch, on the ruling of the Branch Mentor,  
6 must be made in writing to the Executive Committee. Until the Executive  
7 Committee rules on the appeal the decision of the Branch Mentor will remain in  
8 effect. Rev. Article Number from 8 - B to 9 - B. 6/13/20

9  
10           **Article 10** - Central Council Members shall be appointed to communicate  
11 with and assist District and Branch Mentors. They shall contact Mentors once per  
12 quarter to receive updates on Branch and District health, garner feedback and  
13 offer recommendations or advice as necessary. This Central Council Member  
14 shall be available to assist District and Branch Mentors on an as needed basis.

## **CHAPTER X - SUSPENSION AND EXPULSION OF MEMBERS**

1

2           **Article 1** - Members who have failed and continue to fail to abide by the  
3 Articles of Incorporation, Central Council Statutes, Branch By-Laws, or who  
4 have committed or are in the course of committing some act prejudicial to the  
5 purpose of the Federation are subject to suspension for a period not to exceed six  
6 (6) months, or may be expelled from the Federation. Such matters shall be  
7 referred to and decided by the Judiciary Committee.

## **CHAPTER XI - SPECIAL REPRESENTATIVES**

1

2           **Article 1** - Special Representatives may be appointed by the Grand  
3 President at his/her discretion and are under his/her direction. The purpose of the  
4 Special Representative is to aid Branches and/or Districts in need of assistance.

## CHAPTER XII - MEMBERS EMERITUS

1

2       **Article 1 - A.** - After five (5) years of service, an Elected Member who  
3 ceases to serve in that capacity, shall be named Member Emeritus unless they  
4 have been elected as a Life Member.

5

6       **B.** - Members Emeritus of the Central Council shall (1) have the right to  
7 attend Central Council meetings at their own expense and have the right to speak  
8 but shall have no vote on any matter, (2) when attending Central Council  
9 meetings have his/her meal expense covered to the same extent as Central  
10 Council Members, (3) attend the Annual Convention as a delegate-at-large

12 Convention have his/her registration and banquet fee covered to the same extent  
13 as Central Council Members, (5) be eligible to accept a nomination as a candidate  
14 for the Central Council, if otherwise eligible according to the Statutes, but upon  
15 election shall forfeit the rank of Member Emeritus, (6) be presented a plaque at a  
16 suitable ceremony when joining the rank of Member Emeritus, (7) shall not serve  
17 as an Officer of the Central Council, and \*(8) may Chair and serve on a standing

20       **Article 2 - A.** - A Life Member who ceases to serve in that capacity shall  
21 be named Life Member Emeritus.

22

23       **B.** - Life Members Emeritus - Elect shall be an interim title for a Life  
24 Member whose term is ending following their seventy-fifth (75<sup>th</sup>) birthday before  
25 the date of election of new Life Members at the completion of business at the  
26 June Meeting of the Central Council. Life Members Emeritus - Elect shall (1)

1 have all rights as an elected Central Council Member or Life Member at the next  
2 immediate Annual Convention, (2) become Life Members Emeritus of the Central  
3 Council at the beginning of the Central Council Meeting at the Annual  
4 Convention, and (3) thereafter be titled as Life Member Emeritus of the Central  
5 Council. Rev. 2/11/06

7 **C.** - Life Members Emeritus of the Central Council shall (1) have the right  
8 to attend Central Council meetings at their own expense and have the right to  
9 speak but shall have no vote on any matter, (2) when attending Central Council  
10 meetings have his/her meal expense covered to the same extent as Central  
11 Council Members, (3) attend the Annual Convention as a delegate-at-large,  
12 without compensation for travel or per diem, (4) if attending the Annual  
13 Convention have his/her registration and banquet fee covered to the same extent  
14 as Central Council Members, (5) be eligible to accept a nomination as a  
15 candidate for the Central Council, if otherwise eligible according to the Statutes,  
16 but upon election shall forfeit the rank of Life Member Emeritus of the Central

22 **Article 3** - A Life Member Emeritus or Member Emeritus must maintain  
23 full membership in an active Branch of the Federation in order to maintain  
24 Emeritus status.

## CHAPTER XIII - DISTRICT COUNCILS

1

2           **Article 1** - Three (3) or more Branches may form a District Council. Once  
3 established, they may continue to function as long as two (2) Branches remain.

4

5           **Article 2** - The purpose of the District Council shall be to coordinate  
6 activities in the District, to promote District and Branch activities and to  
7 cooperate with other Districts in Diocesan programs.

8

9           **Article 3** - The District Council shall have administrative, but not  
10 legislative power. It shall confine its activities within the scope of the Articles of  
11 Incorporation and Statutes of the Federation.

12

13           **Article 4** - The original By-Laws of the District and any amendments  
14 thereto must be approved by the Executive Committee before they are effective.

15

16           **Article 5** - It shall be up to the majority of the members of an individual  
17 Branch as to their Branch's participation in the District Council. When a Branch  
18 wishes to either join or withdraw from a District Council, notification of said vote  
19 is to be sent to all Branch members ten (10) days in advance of the meeting when  
20 the voting will take place. Voting must be by secret ballot. A simple majority  
21 will rule.
