# Message from our New Spiritual Director

Dear Friends of the Italian Catholic Federation:

On October 7, we celebrate the Memorial of Our Lady of the Rosary. This title attributed to Mary has been traced to an apparition held by pious tradition to have occurred to St. Dominic in 1214. In the 16th century, Pope Pius V placed the feast of Our Lady of Victory on October 7 in the General Roman Calendar, associating it with the Rosary, for which we honor Mary today.

Not too far from the ruins of Pompeii, Italy, the great Roman city destroyed by the volcano Mt. Vesuvius, there is an area called Valle di Pompeii where the town of Campania is located. In the shadow of the ancient volcano,



a Marian Shrine was erected in the latter half of the 1800's. The shrine is dedicated to Our Lady of the Rosary, named for the Marian image elevated on its high altar.

Our Lady of Pompeii is also known as Our Lady of Victory, with the rosary seen as a spiritual weapon in the battle against sin and evil in the world. As Cardinal Angelo Sodano reminds us, "Gathered round the gentle person of Our Lady of Pompeii, let us resolve to call on her every day for our needs and the needs of the world. We are surrounded by a society that needs more than ever the light of the Gospel. Our world is seeking peace. There are so many sufferings that cry out for help. There is such a great longing for justice and charity! We wish to entrust our hopes to Mary's motherly intercession.

The image of Our Lady of the Rosary represents the long tradition of the faithful who turn to Mary for refuge and hope in their needs. Mary is the throne for her small Son, Jesus. He found his first home on earth within her womb and on her lap. Mary is seated on a throne. It is the throne of the Church. Mary, with her divine Son, reigns in the Church and from the Church, a sign of heaven's continuation on earth. As members of the Italian Catholic Federation, we do not merely believe, we know, that the rosary is the most powerful recitation we can make when we desire a miracle or some other grace from

God. By reflecting on Our Most Holy Mother's experiences and the life of Jesus, we become more like the woman who bore all things for the sake of obedience to God's will. With the repetition of the prayers of the Rosary, we will turn to Mary with the insistent, trusting prayer of a child to his mother.

I was 12 years old. My next journey was in August 1977 where I learned of the land grants given by President Portirio Diaz to Italian immigrants. The Roman Empire is ancient history however all of Italy became unified in 1871 including Papal area of Rome with a new flag design.

From what I have learn since 1977, my famiglia migration, especially three Galeazzi brothers, sailed on the ship Atlantic arriving to Mexico in 1882 to expand their history in the New Land America. Not everyone starts in New York City!!!

My Great Grandfather Giovanni Carlo Galeazzi was 16 years old when arriving in Chipilo on October 2, 1882. In the first five-years, 50 to 75 Italian pioneer immigrant families settled as the colony grew. Chipilo is approximately 70 miles south of Mexico City, near the outskirts of Puebla, Puebla (today's 4 million people).

# Book Review: Cambridge Street

#### *Cambridge Street* By Steven Decker Cambridge Street Publishing, 2017

In *Cambridge Street*, a fictional piece inspired by the life of his mother's Italian immigrant family, Steven Decker explores the experiences of Italian immigrants in the early part of the 20th century. Through vivid descriptions and well-developed characters, Decker captures the "heartbreak, bravery, and struggle of millions of people who came to the United States a century ago." His novel focuses on the Tomaso family—beginning with their life in Sicily and following them to Chicago in the 1920s.

The author summarizes the plot when he writes, "In the early 1900s, the Mafia controls much of Sicily, the government is corrupt, and taxes are exorbitant. As a result of the terrible conditions and the limits of their crops, Tomas and Katerina are forced to send their three grown sons and their grandchildren to live in America. It is a heart-breaking split: grandparents forced to say goodbye to grandchildren knowing they will likely never see them again. Parents and sons splitting from each other. Paolo and Gianna, their two young children and the two younger brothers endure a painful farewell to the people, the farm and the life they love. They arrive in Chicago on Christmas Day, 1917. The sprawling, dirty city is not like anything they could have imagined or dreamed. The family moves into a fourth-floor apartment in a run-down tenement building on Cambridge Street in the Little Sicily section of town. Called Little Hell in the papers, the slum neighborhood deserved the title. The family soon learns that they are now in the lower class. The two-century family history of hard work and honesty in the Old Country does not matter here. They endure prejudice in the workplace, in the lack of social services and in the absence of police protection. Jobs were hard to find, especially for Italians and even worse for Sicilians. Poverty and discrimination humble them. To make matters worse, the streets are run by mobsters, crooked politicians and dirty police, just like home. Life was tough. They had to be tougher. The family was finally settled and content when a terrible and unforgivable act of violence - committed against them by their Italian countrymen - struck the family, hard. Paolo swears revenge. The local crime boss cannot tolerate disrespect and sends men to kill the young father and husband. Paolo and Gianna's dreams and hopes for their future and for their children hang in the balance as they



decide on the course of action that will define them as people and determine their futures. If they fail, Paolo will die and the family will be left on the streets."

Cambridge Street does an excellent job of pulling the reader into the narrative in what one would admirably call "a page turner." Decker does an excellent job of describing his characters so that they illustrate the themes he wishes to explore at the time. For example, early in the novel, Paolo and Gianna are presented in an idealized state - young, innocent, and pure - to establish their goodness and to place them in contrast to other characters in the novel - such as Renzo, Pablo's brother - too worldly, cavalier, and troubled. Decker also does a very fine job of describing the environments in which the characters live - exposing the reader to tenement life in Little Sicily, Chicago. One cannot help but realize the struggle and tragedy that thrived in such neighborhoods. If Decker's goal was to honor the memories of his Italian immigrant family, he has indeed succeeded.

Steven Decker is a lifetime Chicago area resident, a father, grandfather and a military veteran. "I always loved to write," he said in a recent interview. "During my career, I wrote training manuals, marketing materials and short stories for fun but I always wanted to create a novel. Now I have the time to write and an important message to share."

Decker grew up in a large, thriving Sicilian family on the north side of Chicago. His first novel, *Cambridge Street*, is crafted around many of the events that deeply affected his Sicilian immigrant grandparents, mother, aunts and uncles during the Roaring Twenties. Decker says, "I wrote Cambridge Street to honor the memory of the millions of immigrants who came to America at the turn of the last century. The bravery of those people, many who arrived at our shores with only a few dollars and who spoke little English, was enormous. We must not let their sacrifices be forgotten."

## Family Recipe Deborah Rodondi Grand President

## Ropa Vieja (translates to "old clothes") Cuban dish

1 large yellow onion, thinly sliced in half moons

6 garlic cloves, crushed

2 medium green bell peppers, remove stem and seeds, slice thinly

1 (14.5 ounce) can diced tomatoes with juice (I used Italian seasoned diced tomatoes); I also added some cherry tomatoes (sliced) that I had in the kitchen

<sup>1</sup>/<sub>4</sub> cup yellow mustard

1/3 cup raisins

<sup>1</sup>/<sub>2</sub> cup pimento stuffed green olives, (I also added kalamata black olive about 1/3 cup), sliced

3 Tbls. Brine from green olives-hold to end of cooking

2-3 lbs. boneless chuck roast, trim off large pieces fat or gristle, cut into 3-4 pieces

2 tsp. kosher salt

1 tsp. pepper, freshly ground

2 tsp. ground cumin

Fresh cilantro for garnish, optional

#### Preheat oven to 300 degrees.

In a heavy ovenproof pot (Dutch oven), put the onions, bell peppers, garlic, diced tomatoes (with juice), mustard, raisins and olives. Mix well.

Sprinkle chuck roast pieces all over with salt, pepper and cumin. Place the pieces of chuck roast in the Dutch oven and push into the mixture. Cover the pot tightly with lid or aluminum foil. I cooked in crock-pot for 6-hour slow cook

Cook about 3 hours, until beef is tender and shreds easily with tongs or forks. Add olive brine to the mixture. In pot, shred beef and mix with juices Season to taste with salt and pepper.

Don't let this turn you away from this delicious dish that originated in Spain and became popular in the Canary Islands, Cuba and Puerto Rico. As with any recipe, there are many variations—including using tomato paste and wine instead of the diced tomatoes

## **The Italian Catholic Federation** St. Francis Borgia – Branch 392 Honors Reverend Joseph A. Mulcrone with the 2022 Mother Cabrini Award

The Italian Catholic Federation – Branch 392 will present the Mother Cabrini Award to Reverend Joseph A. Mulcrone on Sunday, November 6th, 2022. This award is given each year to individuals who continuously give of themselves to serve the church, community, and needy with compassion and selflessness. Over the years, Father Mulcrone has demonstrated faith, leadership, and dedication in his work. His assistance to the deaf and disabled has captured the true spirit and humanity of St. Francis Xavier Cabrini. Like Mother Cabrini, Father Mulcrone (also known as "Father Joe" to his friends) has touched hearts in the United States as well as many other foreign countries. He is truly an individual to be admired for his continuous good works.

Father Joseph A. Mulcrone was born November 24, 1945. He was the oldest of eight children born to Edward and Mary Frances Mulcrone. He grew up on the west side of Chicago. He graduated from Resurrection Grammar School in 1959, Quigley South Seminary in 1963, served his deacon year at St. Ferdinand Parish, and was ordained a priest for the Archdiocese of Chicago on May 11, 1971.

Father Joe's brother, Reverend Tom Mulcrone, is also a priest of the Archdiocese of Chicago. Father Tom Mulcrone was the chaplain for the Chicago Fire Department for thirty years.

Father Joe's first assignment was St. Nicholas Parish in Evanston. He then was in residence for two years at Christ the King Parish in Chicago. In August 1977, Cardinal Cody appointed him as full-time pastor for the deaf community in the Archdiocese of Chicago. (Father Joe's dedication to and compassion for the deaf started at an early age as his maternal grandparents were deaf.) Since that appointment Father Joe continues to serve the deaf community. He has lived in residence at St. Francis Borgia Parish since 1983.

Throughout his career, Father Joe has worked to the betterment of persons

with disabilities. He has served on the Board of Directors of Anixter Rehabilitation Center, Access Living of Chicago, and the Pilsen Wellness Center (all of which are located in Chicago). Nationally, he has served on the boards of the National Catholic Office of the Deaf, the Ministry Formation Program for Deaf Persons, and the Deaf Catholic Youth Initiative for the Americas. Over the years his work has brought him to Mexico, Ecuador, Venezuela, Chile, Guatemala, and recently to Panama. He has lectured around the United States, and also at the Vatican (in 2010). He has helped organize pilgrimages to the Vatican for deaf persons in 2008, 2009, and 2018.

While Father Joe will tell you that he does not have a drop of Italian blood, he absolutely loves to go to Italy. In fact, when we last visited with Father Joe he was preparing to travel to Rome for meetings at the Vatican. While in Rome he did not miss a chance to go for lunch and dinner and of course the delicious gelato.

Today Father Joe lives in residence at the St. Francis Borgia Parish and continues to serve the deaf community in the Chicago area, providing spiritual assistance and helping those in need. He continues his work, seeing to the spiritual needs and well-being of the disabled, with dedication and compassion

# Saturday at the ICF 91st Annual Convention

F ather George Aranha, San Jose Diocesan Chaplain, led a moving MEMO-**RIAL MASS** in honor of past members, family and friends. He welcomed all to remember those who have passed and to keep their memories in our heart. Allen and Crystal Watts' joyful voices raised in song reminded all gathered that "a new dawn is rising to bring your light to all the world." Will and Nancy Seppi of the Family of the Year and Grand Sentinel Teresa Helfand served as lectors.

Following mass, members had their choice of two workshops: one addressing FAITH & HERITAGE and the other a CHARITABLE CHECK-IN.

- Francesca Taylor of Branch 67, Los Angeles led a heritage-based seminar exploring ICF patroness St. Frances Cabrini's role in welcoming Italian American Catholics back to the church. Francesca also recounted her journey to the original Cabrini convent in Codogno, Italy and the Centro Cabrini. The workshop displayed a tablecloth and napkins crafted and used by St. Cabrini. The workshop was a highly detailed and informative account of the legacy of St. Frances Cabrini and the strong connection of the present to the past.

- The Charitable Check-In workshop was led by several Central Council members. They provided an overview of Cooley's Anemia, Scholarship, Gifts of Love and the Providenza Seminary program. While Cooley's Anemia is the ICF National Charity, branches have control over where their greater portion of their donations go.

**COOLEY'S ANEMIA** received \$41thousand this year. ICF's support has been critical to the development of treatment and research in this disease and others like it. According to a report out of UCLA, there has been tremendous progress in developing a curative program including gene therapy to offer hope for patients and their families.

ICF has given over \$2 million in **SCHOLARSHIPS** to students since the program began in 1964. Over 60,000 applications have been received. The first-year scholarships are posted in the convention issue of the *Bollettino*. No need to donate the full amount for the scholarship. Partial donations are greatly appreciated.

Teresa Helfand encouraged members to spread the word of **GIFTS OF LOVE** for fundraising as well as submitting applications for those in need. The money is distributed to those with a specific medical need including hearing aid batteries and mattresses for the homeless shelter.

The **PROVIDENZA FUND** provided support to seminary and priests in training. With the global shortage of priests, this is an important issue A portion of annual dues is donated automatically to the Providenza Fund. It is up to the individual branches to determine the level of fundraising and contributions their branches value.

A joint **FELLOWSHIP WORKSHOP** followed the individual sessions. Three branches presented key findings and methods for growing and developing their branches. Representatives from Br. 39 Merced, Br. 111 Montebello and Br. 227 Aptos all shared strategies that worked and where they struggled.

**BRANCH 39's** outreach includes a month's newsletter with a definite Italian flair, highlights from the parish as well as the branch. Also, they use a Sunshine program with a phone tree. They engage in virtual board meetings as well as drive thru fundraisers such as a pre-order for pasta sauce/gravy. They also offer regular Stations of the Cross and a Coffee & Donuts traded off with other parish groups.

**BRANCH 111's** activities also include a monthly newsletter that is emailed as well as hard copy. They have regular meetings at the park. For St. Joseph's table they sought out table sponsors. The pasta dinner was free.

**BRANCH 227** shared how they had relocated to a new parish that was more open and receptive to the ICF activities and fellowship. They are ramping up again and hope to launch fish frys and other events in their new location with the support of the parish priest.

#### **CONVENTION GENERAL SESSION**

Patty Jarrett from Br. 72 led the session in the **Opening Prayer**. Franklyn Lopez, Jr. gave the **Federation salute**. Grand President Deborah Rodondi read the letter from the ICF Spiritual Director Fr. Chris Bennett. He was unable to attend due to being on a pilgrimage. Lauren Kilcullen gave the **Credential Committee's Report** and thanked Carmen Kilcullen and Perry Shurko for their help.

**First time delegates** were recognized and welcomed. Running ICF is a collaborative process. After the approval of Lisa Crudo's **Grand Treasurer's report**, the proposals for potential change to the **ICF By-Laws** were raised. Considerable discussion over various issues occurred and the proposal were voted on.

**Candidates for Central Council** gave their speeches: Rosemary Cook, Lisa Crudo, Maria di Paolo, Pat Mages, Kenneth Marshall, Vince Piro, Perry Shurko, Theresa Sabatella Shaw and Lauren Kilcullen.

## Responsible Beverage Service Act:

Beginning July 1, 2022, the Responsible Beverage Service Training Act will go into effect. The law requires that anyone who serves alcohol, manages servers, delivers alcohol, takes orders, or checks IDs at a business that serves alcohol on-site must be trained to serve alcohol legally and safely to the public by August 31, 2022. The law authorized the California Department of Alcoholic Beverage Control (ABC) to establish the Responsible Beverage Server Training Program (RBSTP). Under the program, every alcohol server and their manager must have a valid Responsible Beverage Server (RBS) certification from ABC.

The ABC is now requiring that one person who represents their organization complete a course and pass a test, "online is ok" as part of the Responsible Beverage Service Act. That person is issued an ID number and that number is required when applying for the license for any event where alcohol is served.

The website explains it all and has a short video on the application process. The individual who is certified must be in attendance whenever alcohol is served. So, the branches will have to choose someone to become a certified person.
